PROBLEM/ISSUE STATEMENT:

This proclamation recognizes April 22, 2012, as Earth Day in Shoreline. It calls upon residents to celebrate this 42nd Anniversary of Earth Day by committing to protect our natural environment for ourselves, our children and future generations.

One successful example of our residents' commitment to build and protect our natural environment is the work done by the grassroots Pathway Project group, which is made up of Echo Lake residents. By transforming a secluded, inaccessible section of right-of-way into a beautiful, universally accessible pathway at Densmore Avenue N and N 188th Street, they not only supported the health benefits of walking, but also improved the surrounding habitat for native plants and wildlife.

The Pathway Project group viewed this shared, natural area as an asset with community value. They remained flexible throughout the project, realizing that their original goal of a community garden was not possible, due to lack of an onsite water source. In addition, they organized and inspired a significant number of volunteers through their vision of what could be done at the site.

Suzanne Wynne, Project Lead for the Pathway Project group, will accept the Earth Day Proclamation with the Council's appreciation of their volunteer work to enhance and protect Shoreline's environment.
