

ORDINANCE NO. 208

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SHORELINE, WASHINGTON, AMENDING ORDINANCE NO. 184, AS AMENDED, BY INCREASING THE APPROPRIATION FROM THE ROADS CAPITAL IMPROVMENT FUND AND ADJUSTING BUDGETED AMOUNTS FOR TWO CAPITAL IMPROVEMENT PROJECTS

WHEREAS, the 1999 Budget was adopted in Ordinance No. 184; and

WHEREAS, the 1999 Budget included appropriations for the 1999 capital improvement plan, including two sidewalk projects on 175th Street, one on the northside and one on the southside; and

WHEREAS, the current construction bid for the two sidewalk projects requires additional funds for the northside sidewalk project and less funds for the southside project than were included in the 1999 budget;

WHEREAS, the current construction bid for the two projects together will also require the City to increase the funding available from the Roads Capital Improvement Fund by \$56,385 to complete both of the projects; and

WHEREAS, the City of Shoreline is required by RCW 35A.33.075 to include all revenues and expenditures for each fund in the adopted budget;

NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF SHORELINE, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Funds for 175th Street Sidewalk Projects. The City Manager is hereby authorized to expend an additional sum of \$56,415 from the Roads Capital Fund for the two 175th Street Sidewalk Projects and amend the 1999 budget for the two existing capital improvement projects as follows:

North 175 th Street Sidewalks – Southside:	\$ 142,000	\$ <u>224,658</u> in 1999
---	------------	---------------------------

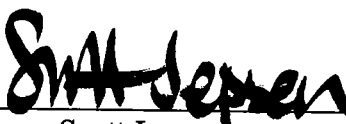
North 175 th Street Sidewalks – Northside:	\$ 114,000	\$ <u>87,757</u> in 1999
---	------------	--------------------------

Section 2. Net Impact on Roads Capital Fund. This ordinance increases the expenditure authority for the Roads Capital Fund by \$56,415 to a total of \$2,161,641 for 1999 and decreases the budgeted ending fund balance to \$6,336,004.

Section 3. Severability. Should any section, paragraph, sentence, clause or phrase of this ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this ordinance be preempted by state or federal law or regulation, such decision or preemption shall not affect the validity of the remaining portions of this ordinance or its application to other persons or circumstances.

Section 4. Effective Date. A summary of this ordinance consisting of its title shall be published in the official newspaper of the City and shall take effect and be in full force five (5) days after the date of publication.

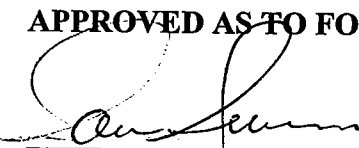
