The PRCS/Tree Board was created to provide an avenue for citizen input on park maintenance and operations, design matters, programs and services in sports, leisure, cultural activities and the management of trees on City-owned public and right-of-way property. The Board acts in an advisory capacity to the City Council.

The Board is comprised of seven adults and two youth who meet the 4<sup>th</sup> Thursday of most months to discuss items related to the topics above. Occasional special meetings may be called, and an Arts Subcommittee regularly advises City staff on a variety of 1% For the Arts projects and other arts place-making activities. Youth members must be between 15 and 19 years of age and are non-voting members. At this time, one youth position is filled. Adults serve four-year terms, while youth serve one-year terms.

Most of the current Board members have one year or less of Board experience. Long-term Board members Bill Clements and Carolyn Ballo reached term limits last year after serving three consecutive four-year terms. At tonight's regular Council meeting, we will acknowledge Kevin McAuliffe who resigned his position in March, 2014 after serving on the Board for nine years. As a result, only two Board members have more than one year of experience: Chair Katie Beth with three years, and Jesse Sycuro, Vice-Chair, with five years experience.

New members of the Board have spent much time learning their role on the Board, dealing with design issues at Sunset School Park, guiding staff on public art programs and projects, and creating the draft Urban Forest Strategic Plan. Attached is a copy of the 2014 Board Work Plan approved in January. The dinner meeting will be a good opportunity for Council and Board members to discuss the Council's expectations for the Board, and to modify the work plan if needed for the remainder of the year.
