The Parks, Recreation and Cultural Services (PRCS)/Tree Board is interested in having an opportunity to talk with the Council about what priorities Councilmembers may see for the PRCS/Tree Board. Over the past several years the PRCS/Tree Board has been engaged in several significant planning projects including the development of the Parks, Recreation and Open Space Plan, the community and aquatics center design and program, priority park investments concept designs, public art plan and the aging adults strategic action plan. The Board is likely to have a work planning retreat this fall. It would be beneficial to the Board members to hear from Councilmembers any ideas or direction they feel is important to address.

Possible discussion questions:

- 1. What are PRCS/Tree Boardmembers hearing from members in the community regarding issues affecting the park system, recreation offerings, the potential Community and Aquatic Center, etc.? What are Councilmembers hearing that may helpful to relay to Boardmembers?
- 2. How can the PRCS/Tree Board support the Council as they deliberate and decide about putting the Community Aquatic Center ballot measure before Shoreline voters this fall?
- 3. What is the Council's vision and goal for a future Parks Foundation? What role should the PRCS/Tree Board play in developing a Parks Foundation, if any?

- 4. Are there issues Councilmembers are concerned about that they don't think are being addressed by PRCS staff or the Board? How can the Board best engage in these issues?
- 5. Considering these projects and the challenges they are trying to address (aging population, environmental degradation, meeting the challenges of growth, aging infrastructure), how do they fit in with the other challenges facing Shoreline and local governments in general?
