On Monday, October 10, the City Council will have the opportunity to meet with the Shoreline School Board to discuss topics of mutual interest. Below are some topics that have been jointly identified as topics for discussion.

Shoreline School District

In the spring of 2016, Shoreline Public Schools made a commitment to evaluate future instructional configurations to meet the needs of students therefore forming the committee composed of many essential stake holders.

The Instructional Program Planning Committee (IPPC) was tasked to examine three areas: preschool configuration, Highly Capable programs configuration, and grade band configuration. As they examined these areas, the committee was asked to reflect on current information such as: "instructional programming; standards alignment and requirements; best practices for delivery of rigorous content; addressing the social emotional needs of students; anticipated future needs."

While the IPPC recommendations could have ramifications for facilities the committee's purpose was to address the instructional needs of students and staff.

In the fall of 2016, community and staff meetings will take place to share the results of the IPPC's work, its recommendations and gather feedback from stakeholders.

The IPPC's work is informing the School District regarding decisions of future facility needs in conjunction with how to meet their education objectives. The School Board is considering a potential ballot measure for 2017 to provide funding for capital investment in the District's facilities.

Light Rail Station Planning Update

On Monday, September 26, the City Council adopted the 145th Subarea Plan including land zone changes for the area around the future light rail station. Attachment A reflects the adopted zoning map. The adopted zoning becomes active in two phases – Phase 1 is immediate and Phase 2 is scheduled to activate in 2033, 10 years after the Light Rail Station opens.

Parks, Recreation and Open Space Master Plan Update

In January 2016, the Parks, Recreation and Cultural Service Department (PRCS) began an 18-month process to prepare an update to the Parks, Recreation and Open Space (PROS) Plan. The Plan establishes a 20-year vision and framework for Shoreline's recreation and cultural programs, and guides maintenance and investment in park, recreation and open space facilities.

This process has included an extensive public engagement component including a SWOT (Strengths, Weaknesses, Opportunities & Threats) analysis of existing parks, facilities and programs.

In addition to completing a SWOT analysis for each park, specific actions that could be taken to secure our foundation and shape our future were generated and are available at: shorelinewa.gov/prosmeetings. Several key themes emerged:

- 1. Upgrade and enhance existing parks and facilities
- 2. Manage impacts from future growth including acquisition in the station subareas and along Aurora
- 3. Improve safety
- 4. Strengthen access to nature; including greenways and wildlife corridors
- 5. Increase connectivity to parks, recreation and open space facilities
- 6. Expand walking and trail-related activities
- 7. Increase connectivity to parks, recreation and open space facilities
- 8. Increase options for adults and seniors
- 9. Add and improve access to aquatics facilities and programs
- 10. Expand indoor exercise and fitness opportunities
- 11. Support arts and cultural opportunities
- 12. Create multigenerational and multi-cultural opportunities
- 13. Improve access to community gardens and healthy eating
- 14. Continue community partnerships in providing parks, open space and recreation programming
- 15. Improve availability of information about facilities and programs

The City Council anticipates adopting an updated PROS Plan mid 2017.

Police Partnerships: Existing & Future Opportunities

As the City continues its focus of Police/Community relationship development, the Police Department is looking for opportunities to enhance engagement with the youth in our community.

Greg McKinney, School Resource Officer, is taking an active role in looking for enhanced engagement opportunities. Most recently, he along with other Police staff and the City Manager, met with the Shorewood Black Student Union on Thursday, September 29. Approximately 60 to 70 students attended and they had very relevant questions about the Black Lives Matter movement, Police training in regards to bias-based policing and de-escalation practices, police accountability and the City's commitment to inclusion of a diverse community. We hope to meet with the Shorecrest club in mid-October. Dr. Tanisha Brandon Felder has also reached out to the Police Department to see if they would like to participate in a Social Justice Mini-Conference being organized by the Shoreline Schools Equity and Family Engagement Department on May 15, 2017 for middle and high school students

Officer McKinney is also looking for "fun" ways to interact with students, and the first Shoreline Police vs. Shorewood Girls Volleyball match was held on October 5. This winter there are some plans for a bowling tournament and in the spring a Shoreline Police vs. Girls Fastpitch game.

The City Manager and Superintendent are also exploring opportunities for more regular police drop-ins at all schools including potential police/student lunch opportunities.
