A couple of times per year, the Council discusses various operational issues that pertain to their legislative body. Tonight, there are multiple topics that staff would like to discuss with Council and topics that Councilmembers have raised for the Council's consideration.

### **Council Strategic Planning Workshop Location, Date and Focus**

Every year, the Council holds an annual Strategic Planning Workshop for annual goal setting as well as for other topics. The annual workshop is typically held in the spring (end of February/early March). This year, the workshop was held Friday and Saturday, March 3 and 4, 2017 at the Talaris Conference Center (March 3) and the City Hall (March 4).

Staff would like Council to discuss when you would like to hold your annual workshop, along with a discussion on a location and a focus for the workshop (outside of Council's traditional goals setting task.)

- Would Council like to continue to hold your workshop at Talaris and City Hall? Another location?
- What themes or focus would Council like for the workshop so that staff can begin exploring how to implement Council's ideas?
- In 2017, Council was joined by the Planning Commission for lunch and a panel discussion on market attractiveness to private investment. Is Council interested in inviting a group(s)/committee(s) to your annual workshop? Is there another panel discussion you would like to have?

### **2018 Proclamations**

Attachment A to this memo provides the proclamations that Council issued in 2017. Staff would like Council to review this list to confirm that these are the proclamations that the Council would like to continue to present at Council meetings next year. If there are any proclamations that Council would like removed or added, staff would request that Council have that discussion.

In addition to this list, the attachment also provides a list of proclamations that have been presented at Council meetings in prior years and proclamations from this year that were issued by the City but were not presented at a Council meeting. This additional information is being provided for Council's information.

### **2018 Board/Commission Vacancies and Appointments**

While there are no Parks, Recreation and Cultural Services Board vacancies identified for 2018, there are three positions on the Planning Commission that will be up for appointment in April 2018. Commissioner Malek, Mork and Moss Thomas will all complete their terms on March 31, 2018. Commissioner Malek and Commissioner Mork are eligible to reapply for an additional term, while Commissioner Moss Thomas is not eligible for another term.

As well, if elected to the City Council, Commissioner Chang's seat will also need to be filled. Her seat would become vacant on January 1, 2018 if elected. If not elected, Commissioner Chang would be able to continue to serve on the Commission.

If Council is interested in following your normal appointment process as defined in the Council Rules of Procedure 2.4, staff will work with the newly elected Mayor in January 2017 about forming a Council Subcommittee for the Planning Commission Interview and Appointment process. Attachment B provides a proposed overview of the selection process and timeline.

Recruitment for new Planning Commission candidates will be conducted through the following means:

- Announce recruitment process at the December 7, 2017 Planning Commission Meeting; applications would be due on January 12, 2018,

- Advertise the recruitment in Shoreline Area News, City Website, Planning Commission Agenda Email, *Currents*, City Manager’s Report to Council, Facebook, Twitter, and the Council of Neighborhoods December meeting, and
- Create a flier and post it at City Hall, the two Shoreline libraries, the Shoreline Police Station, and the Spartan Recreation Center.

**Council Rules of Procedure Amendments**

The City Clerk is proposing two amendments to the City Council Rules of Procedure. If Council is supportive of these proposed amendments, staff will bring these amendments back to Council for consideration and adoption via Council Resolution at a regular Council meeting. The proposed amendments are as follows.

*Proposed Amendment 1 – Changing Regular Dinner Meeting Room Location*

By statute, in order for an elected body to be able to have regular meetings, the meeting date, time and location must be officially noted in a set of rules or protocols. This keeps the clerk of the elected body from having to note every meeting as a “Special Meeting” of the body. The Council’s official meeting room locations are noted in the Council Rules of Procedure. For Workshop Dinner Meetings, this is noted in Council Rule 5.5.

This Council rule currently states that the regular room location for Dinner Meetings is Council Conference Room 104. Given that almost all Dinner Meetings that are intergovernmental in nature or require audio/visual support (PowerPoint) are held in a larger 3<sup>rd</sup> Floor conference room, staff suggests making the new larger Conference Room 303 Council’s default Workshop Dinner Meeting location. This would mean that any Dinner Meeting held in Room 104 (or another room) would just need to be noted as a Special Meeting on that meeting’s agenda.

The proposed amendment to Council Rule 5.5 is as follows:

5.5 The Council shall hold ***Workshop Dinner Meetings*** on the second and fourth Monday of each month at 5:45 p.m. in ~~the Council~~ Conference Room (~~C-104~~303) of ~~the~~ Shoreline City Hall, located at 17500 Midvale Avenue N, Shoreline, Washington. Should any meeting occur on a legal holiday, the meeting shall be canceled. There will be no Workshop Dinner Meetings between December 15 and the end of the year.

*Proposed Amendment 2 – Public Comment Testimony Visual Aids*

This proposed amendment was suggested by Council to help manage how the public may support their public comment testimony by using visual aids. This proposed rule would allow commenters to use visual aids at the speakers podium during public comment (i.e., hold signs, objects, etc.), but makes it clear that commenters may not use PowerPoint and may not approach the dais to pass out materials or have objects passed to the Council. Only *paper copies of materials* may be submitted to the City Clerk for Council distribution. The proposed amendment, which would be a new subsection (Subsection 6.10) of Section 6 – Public Testimony of the Council Rules, is as follows:

6.10 During the "Public Comment" portion of the meeting, speakers will not be permitted to present testimony via electronic methods (e.g. PowerPoint). Speakers may utilize visual aids. Paper copies of all materials may be submitted to the City Clerk to distribute to the Council at the dais.

### **Purpose of Council Reports**

Council Reports at Council meetings are identified in Council Rule of Procedure 5.3(A)(4). However, Council Reports are just identified in this Council rule as part of the normal order of business for Council meetings; their purpose in the Rules is not articulated. Mayor Roberts would like to discuss whether Council Reports should only be for City-related businesses, such as to report on a regional committee, an event that a Councilmember attended on behalf of the City, or work the Councilmember was engaged in as a Councilmember for Shoreline, or whether this agenda item time should also be able to be used to allow Councilmembers to make more general or personal statements about their beliefs or a statement of conscience, which may or may not be directly related to their work as Councilmembers.

### **Continued Use of the City Council's Voicemail Service**

As Councilmembers all have City-issued cellular phones, Mayor Roberts would like to discuss with the Council whether Council would like to discontinue the use of your City voicemail lines. These lines are publicized on the City's website and in Currents. Staff would swap out Council's voicemail numbers with your cell phone numbers everywhere those numbers are publicized if Council is interested in making this change.

### **Discontinuation of the City's Agenda Information Line**

Staff has identified another legacy phone line that provides very little, if any, value but takes staff work to continue to manage. The City's Agenda Information phone line (206-801-2236) is a line residents can call to hear the current City Council and Planning Commission agendas. This phone line is no longer publicized on the City Council section of the website or in Currents, but it is publicized on the [Planning Commission Meeting Agendas and Minutes](#) webpage.

In speaking with staff, they are not aware of any citizens who regularly use this line to receive agenda information. If this line were to be discontinued and a citizen called about an upcoming agenda, staff would point the citizen to the City's website or would read them the agenda information over the phone. Staff recommends that this phone line be discontinued.

### **Public Hearing Public Comments**

When Public Hearings are held on Council agendas, the public hearings have their own stand alone public comment time, which typically follows the staff presentation but precedes Council discussion on the topic. Prior to General Public Comment, the Mayor will often state that if a commenter is attending the meeting to provide comment for the Public Hearing item, that the commenter please provide their comment during the Public Hearing Public Comment period unless they have to leave the meeting early. Councilmember Salomon would like for Council discuss why the Council asks

commenters to wait for this specific comment time. While the Council must still hold this dedicated public comment time for the Public Hearing item, could the Mayor state that a commenter can provide comment at either the General Public Comment time or during the Public Hearing Public Comment time?

**Agenda Planner Review**

This is an opportunity to look at the Council's Agenda Planner (Attachment C) and review what is proposed for your agenda for the remainder of this year and in the 1<sup>st</sup> quarter of 2018.

## **Planning and Community Development**

### **Proposed 2018 Process for Selecting Planning Commissioners to Fill Impending Vacancies**

- Deadline to receive Planning Commission applications to the City Clerk: January 12, 2018.
- The Mayor, once selected on January 8, 2018, will solicit interest from Councilmembers for three Councilmembers to serve on the Planning Commission Interview Panel Subcommittee. The Mayor will circulate his recommended Subcommittee appointment list to the Council by January 15<sup>th</sup>. The Mayor will appoint the Subcommittee by January 22<sup>nd</sup>. If nominees for the Council Subcommittee are referred to the full Council for confirmation as per Council Rule of Procedure Rule 2.3(F), Council will vote on the Subcommittee at its January 29<sup>th</sup> meeting. The Subcommittee will receive applicant applications by January 30<sup>th</sup>.
- The Subcommittee will review the applications received and decide who to interview (if interviews are desired) the week of February 5<sup>th</sup>. Staff will also provide an overview of the interview process, if desired, and provide interview questions to the Subcommittee the week of February 5<sup>th</sup>.
- The Council Subcommittee will arrange interviews with the candidates during the week of February 12<sup>th</sup>. Council Subcommittee interviews and recommend appointee selection will follow the process outlined in Council Rule of Procedure 2.4.
- The full City Council will confirm appointments at their February 26<sup>th</sup> Council meeting. If there is a vacant seat on the Commission, one appointment could begin immediately to fill the vacant seat.
- Staff will schedule a new Commissioner orientation in March, and the new Commissioner(s) first meeting will be April 5, 2018.
