PROBLEM/ISSUE STATEMENT:

Shoreline resident Judge Richard Eadie is a familiar face at Shoreline City Council meetings, as he has sworn in newly-elected Councilmembers every two years since the City was incorporated. Now beginning his second term as Presiding Judge of the King County Superior Court, Judge Eadie was recently elected President of the National Conference of Metropolitan Courts. This organization will be bringing a national conference to Seattle in the fall.

Judge Eadie is a lifelong resident of this area, a graduate of Ballard High School, a United States Navy veteran and a graduate of the University of Washington. In addition to his professional contributions, Judge Eadie has supported his community in many ways. He was appointed to the Board of Trustees of the King County Library System in 2002 and is now President of the Board. He is also on the Board of Directors of the Shoreline Historical Museum. Other community activities have included serving on the Board of Directors of the Center for Human Services, the Board of the Northwest Hospital Foundation and on the hospital's Hospice Advisory Committee.

Tonight's commendation recognizes Judge Eadie's many contributions to the quality of life of our community.
