Proclamation of Child Abuse Prevention Month

PROBLEM/ISSUE STATEMENT:

Each week in the United States the child protective service agencies receive more than 50,000 reports of suspected child abuse or neglect. In approximately two-thirds of these cases, the information provided in the report is sufficient to prompt an assessment or investigation. As a result of these investigations, more than 2,450 children per day are found to be victims of abuse or neglect. In 2002, an average of nearly four children died every day as a result of child abuse or neglect.

The impact of child abuse and neglect is far greater than its immediate, visible effects. These experiences can shape child development and have consequences that last years, even lifetimes. Studies have found abused or neglected children to be at least 25 percent more likely to experience problems in adolescence; and as adults, such children have an increased likelihood of criminal behavior, involvement in violent crime. abuse of alcohol and other drugs, and abusive behavior. Research now shows that the physical, psychological and behavioral consequences of child abuse and neglect impact no just the child and family, but the community as a whole.

April is Child Abuse Prevention month and calls attention to the importance of all of us working together to prevent child abuse. Caroline Shelton, of the Children's Response Center, will be present at the meeting to accept the proclamation. The Children's Response Center works to provide "a safe and nurturing environment, a home and community free of sexual assault and other trauma and the pain and disruption these cause." In 1989 it was designated as a national Community Partnership Example of Excellent by the American Association for Protecting Children.
