PROBLEM/ISSUE STATEMENT: Staff is requesting that Council authorize the City Manager to execute a Local Agency Agreement with the Washington State Department of Transportation (WSDOT) to obligate \$5,528,189 of Congestion Mitigation/Air Quality (CMAQ) Grant Funds for the Right-of-Way Phase of the Aurora Corridor Project (N 185th Street to N 205th Street).

In accordance with the City's purchasing policies, Council authorization is required in order for staff to obligate grant funds exceeding \$50,000. Additionally, the Washington State Department of Transportation (WSDOT) requires formal authorization of their contracts prior to execution.

WSDOT administers federal transportation funds awarded to the City of Shoreline. A key requirement of this grant is that the CMAQ grant can only be used for the Right-of-Way Phase of the Aurora Corridor Project between N 185th Street to N 205th Street. This grant provides for 86.5% of eligible right-of-way related costs.

FINANCIAL IMPACT:

The Aurora Corridor Project (N 185th Street to N 205th Street) is identified in the City's Proposed 2010-2015 Capital Improvement Program. The following table on the next page provides a summary of the funding sources for this project, and the items under consideration are highlighted in bold.
