BACKGROUND:

Planning Commission

The Shoreline Planning Commission is comprised of seven city residents who are appointed by the City Council and provide guidance to that body for issues related to land use and long-range planning.

This evening we are honoring three former members of the Shoreline Planning Commission: Sid Kuboi, Rocky Piro and David Pyle. Mr. Kuboi and Mr. Piro each served 8 years on the Planning Commission, and Mr. Pyle served 4 years. We would also like to recognize and thank Will Hall who served on the Planning Commission for nearly six years and worked on many of the projects mentioned below. He resigned from his position in December of 2009 when he was elected to the Shoreline City Council.

In their first term on the Commission, Mr. Kuboi and Mr. Piro worked on various quasi-judicial actions, major updates to the Comprehensive Plan and Critical Areas Ordinance, and development of the Parks, Transportation, and Surface Water Master Plans.

In their second term, the two Commissioners and Mr. Pyle worked on quasi-judicial actions, regulations for Hazardous Trees, zoning for Ridgecrest, an update of the Citywide Vision statement, development of the MUZ zone, the CRISTA Master Development Plan, and the SE Neighborhoods Subarea Plan.

In addition to the regular twice a month meetings, the Commissioners attended many special meeting and served on several subcommittees - devoting literally hundreds of hours in service to the City.

Library Board

The Shoreline Library Board is comprised of seven citizens of Shoreline who are appointed by the City Council and provide guidance to the King County Library System (KCLS) for the management and operation of the Richmond Beach Library and Shoreline

Library. The main task of the Shoreline Library Board is to ensure that these KCLS branches in our community serve the educational and social needs of residents.

Tonight we are honoring two former members of the Library Board and thank them for their service.

Lori Lynass served for two years fulfilling an unexpired term. She was instrumental in crafting the 2009-2010 goals for the Board. Ms. Lynass works at the University of Washington and due to work commitments; she is unable to attend the May 17th meeting.

Tom Petersen served on the Board from 2006 until 2010 serving as chair for two years. Besides the Library Board, he is active on the Neighborhood Council and the Richmond Beach Community Association, taking an active role with the Strawberry Festival.

Both Ms. Lynass and Mr. Petersen stated that they very much enjoyed being members of the Shoreline Library Board but due to commitments were unable to continue on the Board at this time. Both have indicated their desire for re appointment in the future.

Parks, Recreation and Cultural Services Board

The Shoreline Parks, Recreation and Cultural Service Board is comprised of nine adult and two youth members. The Board meets monthly and provides information, reviews park plans and makes recommendations to the City Council for park, recreation and cultural service programs.

Tonight we recognize and thank Shari Tracey, a member of the Board since 2007. Ms. Tracey was the co-chair of the successful 2006 Bond Issue and is an active member of ShoreDog. She resigned from her board position in December of 2009 when she was elected to the Shoreline City Council.
