1. CALL TO ORDER

At 7:00 p.m., the meeting was called to order by Mayor McGlashan, who presided.

2. FLAG SALUTE/ROLL CALL

Mayor McGlashan led the flag salute. Upon roll call by the City Clerk, all Councilmembers were present with the exception of Councilmember Winstead.

Upon motion by Deputy Mayor Hall, seconded by Councilmember Eggen and carried 6-0, Councilmember Winstead was excused.

3. CITY MANAGER'S REPORT

Julie Underwood, City Manager, provided reports and updates on various City meetings, projects, and events.

Ms. Kelli Stickney, Outreach & Marketing Manager for Sustainable Works, provided a brief presentation on Sustainable Works programs.

4. COUNCIL REPORTS

Mayor McGlashan noted that former Mayor Robert Ransom's wife, Sharon Ransom, passed away. He expressed his condolences on behalf of the Council.

5. PUBLIC COMMENT

a) Debbie Kellogg, Shoreline, discussed the City's proposed animal control regulations and mentioned that the dog attack incident last fall was not handled to her satisfaction.

Councilmember Eggen commented that the Council did discuss the issue the last time animal control was discussed. John Norris, Management Analyst verified that the case was discussed in December and that King County Animal Control didn't communicate well with City and the City went back and looked at how King County investigated it. King County asked for additional information to see if they could find the owner of animal and the victim wasn't able to identify the animal and the issue is at a dead end. He added that he hasn't heard any new news. Now, he stated, there are postings at Hamlin, but the case has been designated a cold-case.

6. APPROVAL OF THE AGENDA

Deputy Mayor Hall moved approval of the agenda, seconded by Councilmember McConnell and unanimously approved.

7. CONSENT CALENDAR

Deputy Mayor Hall moved approval of the Consent Calendar. Councilmember Eggen seconded the motion, which carried unanimously and the following items were approved:

8. ACTION ITEMS: OTHER ORDINANCES, RESOLUTIONS, AND MOTIONS

(a) Ordinance No. 595, Adoption of New Animal Control Regulations

John Norris, Management Analyst, provided a brief staff report recapping elements of Ordinance No. 595, proposed Animal Control Regulations. He responded to Council questions.

Councilmember Roberts moved adoption of Ordinance No. 595, adopting New Animal Control Regulations. Deputy Mayor Hall seconded the motion.

Mr. Norris discussed the issues raised at the March 7 Council Study Session. He noted that the suggested revisions submitted to the Council by Councilmember Roberts have been incorporated. Councilmember Roberts spoke in favor of the motion and encouraged adoption of Ordinance No. 595. Deputy Mayor Hall concurred.

Deputy Mayor Hall moved to amend Attachment B of Shoreline Municipal Code (SMC) 3.01.012 adding a section entitled "Service Animal Dogs and Cats" and the following sentence: "Service animal dogs and cats and canine police dogs must be licensed but there

is no charge for the license." Councilmember Eggen seconded the motion, which carried 6-0.

Councilmember Eggen thanked the City staff for looking at Mr. Meyers' letter. On another point, he stated it is not clear to him that PAWS takes animals and felt that animals running around without a leash may be more critical issue than not cleaning up waste. Councilmember Eggen moved to revise fees under Section 6.40.060, Animal Violations, from \$50.00 for the first violation to: \$25.00 for the first violation and \$50.00 for subsequent violations. Councilmember Scott seconded the motion.

The Council and staff discussed the merits of the amendment. Following discussion, a vote was taken on the motion to revise fees related to violations, which carried 6-0.

Councilmember Eggen discussed Section 6.30.060(a) and relayed Mr. Meyers' concern that he did not want a blind person to get cited who unknowingly violates the "pooper scooper" law. Councilmember Eggen moved to amend Section 6.30.060(a), adding "This provision will not apply to service animals whose owners have a physical disability which would prevent waste cleanup." Councilmember Scott seconded the motion.

The Council discussed the merits of the amendment. Following discussion, a vote was taken on the amendment, which failed 1-4, with Councilmember Scott abstaining. A vote was taken on the main motion to adopt Ordinance No. 595, Adopting New Animal Control Regulations, as amended, which carried 6-0.

(b) Ordinance No. 598, Approval of Comprehensive Plan and Code Amendments to create Planned Area 3 - Aldercrest

At 7:47 p.m., Councilmembers Roberts and Eggen recused themselves from this item and left the Council Chamber.

RECESS

At 7:47 p.m., Mayor McGlashan called for a five-minute break. The meeting reconvened at 7:52 p.m.

Deputy Mayor Hall moved to approve Ordinance No. 598, Approval of Comprehensive Plan and Code Amendments to create Planned Area 3 – Aldercrest. Councilmember Scott seconded the motion. Deputy Mayor Hall spoke to the motion and noted the past community disagreements about the Aldercrest site. He summarized that he is very happy to move this forward without amendment or change. Councilmember McConnell concurred and spoke in support of the motion. Councilmember Scott also spoke in agreement and commended all who worked to achieve this accomplishment. Mayor McGlashan concluded the discussion with comments in favor of Ordinance No. 598.

A vote was taken on the motion to adopt Ordinance No. 598, Approval of Comprehensive Plan and Code Amendments to create Planned Area 3 – Aldercrest, which carried 4-0.

Mayor McGlashan thanked and acknowledged Shoreline School District Superintendent, Sue Walker, School Board Members, the Ballinger Neighborhood, and Friends of Aldercrest who were in the audience.
