PROBLEM/ISSUE STATEMENT:

The purpose of this action item is to authorize the use of eminent domain for acquisition of certain real properties necessary for construction of the Aurora Corridor Improvement Project, N 192nd to N 205th Streets ("Project") if individual agreements cannot be reached.

The City has contacted affected property owners over the last several months to discuss the Project design and the property needed to construct the Project. At this time, the right-of-way acquisition team has started making offers, and appraisals are underway. Offers and negotiations will continue for the next several months. As with past phases of the Aurora project, all other options will be pursued with the property owners before eminent domain is considered.

In the event individual agreements cannot be reached for purchase of the property, eminent domain is the next step. Passage of this ordinance authorizes the City Manager, or designee, to proceed with eminent domain in the event negotiations with property owners reach an impasse. Eminent domain is a tool to be used should extensive negotiations fail; it is not a given that it will be utilized.

INTRODUCTION

The purpose of this action item is to authorize the use of eminent domain for acquisition of certain real properties for the construction of the Aurora Corridor Improvement Project, N 192nd to N 205th Streets ("Project") if individual agreements cannot be reached

BACKGROUND

City Council adopted the final design for the Aurora Corridor Improvement Project (N 165th to N 205th Streets) on January 14, 2008. The environmental work is complete. The purpose of the Project is to improve the safety and mobility of all pedestrians, transit users, and drivers along Aurora Avenue. The Project will also improve lighting, stormwater management, and improve economic development potential. The project will add business access transit (BAT) lanes, curbs, gutters, sidewalks, landscaping/ street furnishings, plus a landscaped center median for safety with left and u-turn provisions.

In 2009 Council authorized Ordinance No. 527 providing for the use of eminent domain for the Aurora Corridor Improvement Project (N 165th – 185th Street). Staff believes the prior ordinance was critical to keeping the right of way process efficient, timely, and fair.

At this time, design and right-of-way acquisition phases of the Project are funded. Staff projects that the City needs to obtain an additional \$13.95 million in grants to fully fund the construction phase. Given feedback from the City's funding partners regarding the importance of completing the Project, staff anticipates that adequate grant funding will be obtained to complete construction. If adequate grant funding is obtained, staff believes it is reasonable to assume that construction could begin as early as the summer of 2012.

ALTERNATIVES ANALYSIS

In the middle mile of the Aurora project (N 165th to N 185th Street), Ordinance No. 527 was authorized early in the acquisition process. Of the 77 parcels in the middle mile, the City filed eminent domain on 15 parcels (12 owners). Of these, four were resolved by the City Attorney's Office without mediation, 10 were resolved by the City Attorney's Office and Public Works through mediation, and one went to trial.

Since additional right-of-way is needed from over 50 land parcels, it is very likely some property acquisitions will become complicated (Attachment A is a map to use as a key to land parcel numbers). Please note that there are over 190 "parcels" listed in Ordinance No. 608 (Attachment B). All condominium buildings, while a small number of land parcels, must have each unit listed in Ordinance No. 608 as each unit has ownership rights. The legal language associated with each condominium complex will specify whether the condominium board can approve our agreements or if each individual unit needs to sign agreements. Staff recommends authorization of Ordinance No. 608 to keep the right-of-way process on schedule. At this time no parcels have yet settled.

Authorizing the use of eminent domain early in the right-of-way phase lets all property owners know from the beginning that the City intends to utilize this tool should negotiations stall. There are also tax benefits for the property owner when their land is acquired under the threat of eminent domain.

The City is committed to a fair negotiation process as required per the federal and state law which includes dialogue and opportunity for sharing of information. The alternative to this ordinance would be consideration of eminent domain parcel by parcel. Staff does not recommend this approach since it would be time consuming, inefficient and could appear to be singling property owners out when negotiations have stalled.

STAKEHOLDER OUTREACH

Beginning the fall of 2010, the project manager and other staff have met with property owners to discuss the project schedule, design, right-of-way needs, and the right-of-way acquisition process. Staff met with condominium association representatives, but not each individual condominium owner. Staff met with all but two property owners: one has not responded to our correspondence and the other had been met with several times during 185th-192nd Segment discussions and is aware that we will need a minor temporary construction easement. Staff had also met with the Top Tattoo owner (relocation) and the owners of the KFC building (dining room impact). The goal was to introduce all property owners to the project manager, lead design engineer, and lead right-of-way acquisition agent.

Property owners listed within the condemnation ordinance were notified by certified letter that this ordinance was being brought to Council on July 25, 2011. Staff also made a concerted effort to personally notify all property owners (and condominium complex representatives) of the certified letter and Council meeting so they would not be surprised.

COUNCIL GOAL(S) ADDRESSED

Completion of the Aurora Corridor Improvement Project is currently Council Goal #4, "Construct the Aurora Improvements from 165th to 205th Streets."

RESOURCE/FINANCIAL IMPACT

A timely and efficient right-of-way process is economical. Staff believes it is more appropriate and efficient to list all properties into one ordinance. Construction cannot move forward until the Washington State Department of Transportation verifies that all property rights for the project have been acquired. Coming to Council on an as-needed basis is time consuming and would single out individual businesses. Below is a breakdown on the funding for the N 192nd – N 205th Street segment:





WHEREAS, on January 14, 2008, the Shoreline City Council adopted the final design for the Aurora Corridor Project N. 165th - N. 205th ("Project") which has been identified in the 2012-2017 Capital Improvement Plan ("CIP"); and

WHEREAS, the purpose of the Project is to improve the safety and mobility of pedestrians, transit users, people with disabilities, and drivers along Aurora Avenue from N. 165th Street to N. 205th Street; and

WHEREAS, this Project will improve the economic development potential of the corridor, enhance the livability of adjacent communities, and support the City's Comprehensive Plan; and

WHEREAS, the CIP calls for the right-of-way acquisition in 2011 for Aurora Avenue N. $192^{nd} - 205^{th}$ and side streets with construction of Aurora Avenue N. $192^{nd} - N$. 205^{th} to begin in 2012; and

WHEREAS, the Shoreline City Council has determined that the properties depicted and described in Exhibit A attached hereto are affected by this Project and that portions of those properties, as described and depicted in Exhibit A, are necessary to complete the Project including the construction of BAT lanes, medians, sidewalks and underground utilities; and

WHEREAS, the City of Shoreline has the power to acquire lands through eminent domain for the establishment, construction, enlargement, improvement, and maintenance of public streets; and

WHEREAS, sustained effort to contact property owners and interested parties has been made and will continue, and eminent domain action will be taken judiciously after reasonable efforts such as offering possession and use agreements; and

WHEREAS, acquisition of property is categorically exempt from SEPA review under WAC 197-11-800(5)(a); now, therefore,

THE CITY COUNCIL OF THE CITY OF SHORELINE, WASHINGTON DO ORDAIN AS FOLLOWS:

Section 1. Condemnation Authorized. The City of Shoreline shall acquire by negotiation or by condemnation, portions of the real properties situated in the City of Shoreline, County of King, and State of Washington depicted and legally described in Exhibit A attached hereto and by this reference incorporated herein. Those portions of the properties to be acquired by negotiation or by condemnation are legally described and depicted in Exhibit A.

The City Manager or his designee shall adhere to the City of Shoreline Right of Way Procedures and Resolution No. 270, and is hereby authorized and directed to execute all documents for the acquisition of said properties and bring proceedings in the manner provided for by law to condemn, take, damage, and appropriate the lands and property interests described in this section pursuant to the powers granted to the City of Shoreline including RCW 35A.64.200 and Chapters 8.12 and 8.25 RCW. In conducting said condemnation proceedings, the City Attorney, and any


Special Counsel designated by the City Attorney, is hereby authorized to enter into stipulations for the purpose of minimizing damages, including the reduction in area of land or modification of property interests to be acquired for the Project.

The City Attorney is also authorized to make minor amendments to the legal descriptions or maps of properties described in the attached Exhibit A as may become necessary to correct scrivener's errors or to conform the legal description to the precise boundaries of the property required for the project.

- Section 2. Finding of Public Use and Necessity. The Shoreline City Council finds that the acquisition of the property described and depicted in Exhibit A is for a public use and purpose, to-wit: to provide road and sidewalk improvement and underground utilities on Aurora Ave. N. from N. $192^{nd} N$. 205^{th} . The Council further finds the properties described and depicted in Exhibit A are necessary for the proposed public use and for the benefit of the public.
- **Section 3. Purchase Funds.** Funds allocated in the City of Shoreline 2012-2017 Capital Improvement Plan for the Aurora Corridor Project N. 192nd to N. 205th shall be made available to carry out the provisions of this Ordinance.
- **Section 5. Effective Date and Publication.** A summary of this Ordinance consisting of the title shall be published in the official newspaper and the Ordinance shall take effect five days after publication.





AURORA AVE N RIGHT OF WAY


