PROBLEM/ISSUE STATEMENT:

The City Manager presented the 2012 proposed budget to the City Council on October 17, 2011. Department presentations were made on October 24 and November 7. Tonight the Council will hold a public hearing on the proposed budget with special emphasis on 2012 revenue sources including the 2012 property tax levy. Following the public hearing the Council will have an opportunity to continue their discussion of the 2012 proposed budget. The City Council is scheduled to adopt the 2012 Budget on November 28, 2011.

Chapter 251, Laws of 1995, passed by the Washington State Legislature, require the City Council to hold a public hearing on revenue sources for the next year's budget. The hearing must include consideration of property tax revenues and must be held before the property tax levy ordinance is passed and submitted to King County. The City of Shoreline is required to adopt its 2012 levy ordinance and certify the amount to the County Assessor by November 30, 2011. The 2012 Proposed Budget assumes a regular property tax rate of \$1.60 per \$1,000 of assessed valuation.

As prescribed in Shoreline Municipal Code (SMC) 3.01.080 fees shall automatically be updated annually by the July to June Seattle-Tacoma-Bremerton Consumer Price Index for all urban consumers (CPI-U). This index equaled an increase in the CPI-U of 3.15%. Therefore, there will be some fee increases for 2012. The hourly rate for development fees will increase from the current level of \$145 to \$149.50. The 2012 surface water utility fees will be increased by 2.5%. This results in the annual single family residential rate increasing from the current level of \$130.20 to \$133.46. No changes are being proposed in recreation and parks facility rental fees for 2012, as there were minor adjustments to these fees earlier this year.

Since the solid waste utility is considered the City's utility in which the City has chosen to contract with a private provider, the solid waste rates are included in the City's fee

schedule. The City's contract with CleanScapes, Inc. provides for an annual adjustment to the collection fee component of solid waste rates. The adjustment is based on the composite change in three indices that measure the change in inflation, labor, and fuel costs. Adjusted rates become effective on March 1st of each year with customers being notified no later than January 15th, forty-five (45) days prior to the new rate taking effect. The proposed rates for 2012 include an average increase of 7.58% for residential and 7.06% for commercial/multi-family customers.

Attachment A is the proposed 2012 fee schedule along with a comparison to the 2011 fees. The fee schedule will be adopted at the same time the Council adopts the 2012 budget, which is currently scheduled for November 28, 2011.

The 2012 budget includes adjustments to the City's salary schedules. A cost of living adjustment of 2.04% has been included in the 2012 proposed budget. As per the City's compensation policy the City conducted the salary survey for the top third of the City's salary ranges in 2011. There are no recommended changes to the salary schedules as a result of the completed survey. Attachment B is the 2012 proposed salary schedules for exempt (not eligible for over time pay) and non-exempt staff positions.

RESOURCE/FINANCIAL IMPACT:

The 2012 Proposed Budget totals \$54,737,441. Property tax represents 21% of the overall City resources in the amount of \$11,751,000 which includes both the 2012 regular levy and the 2006 bond levy. Utility taxes, franchise fee and utility contract payments account for nearly 15%, \$8,122,959 of the City's revenues. Licenses, fees and charges represent 11% of the City's overall resources and total \$6,121,813. Salary and benefit changes discussed within this staff report result in a net increase of approximately \$194,146 (1.3%), as compared to the proposed 2011 budget.

RECOMMENDATION

Staff recommends that Council conduct the public hearing to take public comment on the proposed 2012 budget, 2012 property tax levy and proposed 2012 revenues. Staff also recommends that Council continue discussion on the 2012 Proposed Budget and provide input to staff.

BACKGROUND

The City collects a variety of revenues to support the ongoing services provided. The following discussion provides detail on the City's major funding sources.

General Fund Revenues

Property Tax

Regular Levy: The 2012 regular property tax levy totals \$10.06 million which is an increase of \$242,000 or 2.5% over the 2011 levy. Of this amount \$9.6 million is programmed to fund basic services in 2012 and \$398,000 will transferred to the Property Tax Equalization Fund to be used in 2014 through 2016. Proposition 1 included an annual escalator based upon the CPI-U index which is 3.15% for the 2012 property tax levy. Although this is the case, it is likely that the full increase will not be levied given the projected 5.1% decrease in assessed valuation as provided by the King County Assessor's Office. If the levy were increased by the full CPI-U change, it would result in a regular property tax levy rate in excess of statutory maximum of \$1.60 per \$1,000 assessed valuation. Since the City cannot exceed the statutory threshold the levy increase for 2012 must be low enough for the property tax rate to remain at or below \$1.60. The actual increase will likely be between 2.1% and 2.5%.

The 2012 new construction valuation is estimated at \$2.4 million, the lowest level in City history. This level of new construction results in \$3,500 of new property tax revenue. In comparing the City's 2012 new construction to other cities in King County, Shoreline ranked 37 out of the 38 King County cities with new construction as a percent of assessed valuation.

The average home value assumed for 2012 is \$319,149. Assuming a regular property tax rate of \$1.60 per \$1,000 assessed valuation, the average homeowner will pay \$509 in property taxes for City services in 2012. This is a \$13 increase from the average payment in 2011.

Bond Levy: Shoreline voters approved a special levy in 2006 to fund parks improvements and the purchase of open space. The 2012 bond debt service levy is projected to be \$1.7 million which will result in a levy rate of \$0.27 per \$1,000 of assessed valuation which is up slightly from the 2011 rate of \$0.26 per \$1,000.

Sales Tax

Sales tax revenue in 2012 will account for nearly 20% of the total 2012 General Fund operating revenues. The 2012 sales tax revenue is projected to grow by \$210,000 or 3.45% to a total of \$6,301,418. This increase is projected to come from the construction of two new high schools by Shoreline Public Schools. Without those two projects, the City's sales tax collections would not be projected to increase from 2011 to 2012. Projected collections for 2011 total \$6,091,418, which is an increase over 2010 of \$345,663 or 6.02%.

Criminal Justice Sales Tax

A major source of dedicated funding for local criminal justice programs is the county-wide criminal justice sales tax of 0.1%. The projected 2012 revenue is \$1,113,330,

which is a slight increase from the 2011 projected amount of \$1,085,000. This revenue source is 3.5% of the total General Fund operating revenues.

Utility Tax

The City collects a 6% utility tax on natural gas, telephone services, sanitation services, cable television, and storm drainage. Projected revenues in 2012 from utility taxes are \$4,105,025 or 12.2% of the total General Fund operating revenues. This is a slight decrease of \$15,975 or 0.39% from projected 2011 utility tax revenues. Utility taxes from natural gas are projected to decrease by 3.55%, \$35,000, from 2011 to 2012.

Public Utility Contract Payments /Franchise Fees

The City has entered into agreements with many of the public utilities that provide services to Shoreline residents. Agreements have been reached with Seattle City Light, Seattle Public Utilities (Water and Sewer), Shoreline Water District, and Ronald Wastewater District. With the exception of Seattle City Light, these utilities pay a contract fee to the City in an amount equal to six-percent of their revenues.

The total projected 2012 revenue from contract payments is \$4,017,934, which equates to 11.9% of the total General Fund operating revenues. This is an increase of \$92,934 or 2.37% from projected 2011 revenue. The increase is primarily from an anticipated rate increase for electricity by Seattle City Light.

Gambling Tax

Forecasted revenues for 2012 total \$1,823,771, an increase of \$111,168 or 6.5% over 2011projections. The 2012 projections include \$200,000 in revenue collections from existing promissory notes and overdue 2011 tax payments.

Development Permit Fees and Charges

Fees are charged for a variety of development permits, inspections and reviews obtained through the City's Planning and Community Development department. These include building, structure, plumbing, electrical, and mechanical permits; land use permits; permit inspection fees; plan check fees; and fees for environmental reviews. In 2012, revenues are projected to be \$641,725. This is just slightly more than 2010 actual collections of \$633,990. 2011 projected revenue totals \$1,222,221 including revenue from the construction of two new high schools by the Shoreline School District.

Recreation Fees and Charges

Fees are charged for participation in recreational classes and activities; swimming lessons and pool admission; athletic field, recreation center, picnic shelter and Spartan Gym rentals; indoor and summer playground programs; and teen trips and classes. Revenue is projected to total \$1,412,735 which is a decrease from 2011 projections of \$35,630 or 2.5%. Revenue projections for 2012 are conservative since pool and facility rentals are currently at full capacity and there has been some decrease in programs usage for youth sports and adult programming. During 2012, revenues from the general recreation activities are projected to decrease by \$13,420 or 2.16%. This is due to returning to the usual summer calendar. In 2011 an additional week of summer camp programs were provided as a result of the delay in the school year for the Shoreline School District. Aquatics revenues are expected to decrease by only \$7,000 or 1.83%.

Revenues from facility rentals are expected to decrease by \$11,250 or 2.62%. Projected 2012 revenue from teen activities is down by \$3,960 or 25.31%.

Right-of-Way Permit Fees

Fees are charged for the use of the City's right-of-way. This revenue source is affected by the level of construction activity occurring within the City. As history shows, collections can vary slightly from year to year based on the level of activity. 2011 projected right-of-way permit revenue is \$215,000, an increase of \$41,614 when compared to 2010 collections. The 2011 growth is primarily a result of significant upgrades to utility systems through franchise agreements. Many of these are one-time investments in utility infrastructure therefore the projections for 2012 are not expected to be as high and have been lowered to \$185,400. This revenue offsets the cost to provide the right-of-way inspection service.

Liquor Excise Tax and Liquor Board Profits

The 2012 budget includes \$595,840 in liquor excise tax and liquor profits from the State of Washington. These revenues are collected by the state and then a portion is distributed to cities based on population. Initiative 1183 (I-1183), on the November 8, 2011 ballot, would privatize the distribution and sale of liquor within the state. Although liquor profits would be eliminated with the passage of I-1183, the Washington State Office of Financial Management estimates that over a six year period, local governments would receive additional revenue of between \$185 and \$227 million as a result of new distribution and retail license fees.

On November 28, 2011, the State Legislature will start a special session to address the projected \$2 billion state budget gap for the next biennium. On October 28, the Governor released her initial recommendations to address the projected budget gap. One of her recommendations includes repealing the sharing of liquor excise taxes and profits with cities. It is unclear at this time what impact the passage of I-1183 would have on shared liquor revenues. If the State does eliminate the sharing of liquor revenues with cities then the City will need to make additional budget reductions to offset the reduction in revenue.

Street Fund Revenues

The City receives revenue from state collected fuel tax to fund street maintenance activities. These revenues do not provide sufficient funding therefore the General Fund continues to subsidize this fund. The total subsidy for 2012 is projected to be \$918,218.

Fuel Tax

State collected gasoline and diesel fuel tax is shared with cities and towns on a per capita basis. This revenue is to be used for street repairs and maintenance. The projected revenue for 2012 of \$1,125,180 a minimal increase of only \$371 or 0.03% over 2011 projected revenue. The tax is a flat amount per gallon sold. Since receipts in this category are dependent on consumption, and not price, an increase in gas prices has decreased the amount of fuel sold

Surface Water Utility Fund

The City contracts with King County to collect the City's surface water utility fee. 2012 collections are expected to increase from 2011 by \$78,869 to \$3,233,639 as the surface water utility fee is proposed to increase by 2.5%.

Capital Improvement Fund Revenues

Capital projects are funded from a variety of revenue sources including: real estate excise tax, fuel tax, grants, debt financing, investment earnings and funds that the City has set aside for capital projects.

Real Estate Excise Tax (REET)

All real estate property sales in the county are taxed at a rate of 1.28%. A portion of these revenues, equal to a 0.5% tax rate, is distributed to the cities by King County on a monthly basis. The use of REET funds is restricted by State law. The first 0.25% of the REET tax rate must be spent on capital projects listed in the City's Comprehensive Plan. These projects could include local capital improvements, including streets, parks, pools, municipal buildings, etc. The second 0.25% of the REET tax rate must be spent on public works projects for planning, acquisition, construction, reconstruction, repair, replacement, or improvement of streets, roads, highways, sidewalks, street lighting, etc. 2012 revenues are projected to increase over 2011 projections by \$72,604 or 7.67% to \$1,018,588. This is still below the original 2011 budgeted amount of \$1.1 million and is still down significantly from collections received over the past few years when real estate activity was occurring at a record pace. Revenue collections reached a peak in 2005 at just over \$2,675,632.

Capital Grants

In 2012, Shoreline is projected to receive nearly \$4.5 million in grant funding from federal, state and local sources to fund a variety of capital projects. The majority of these grants are related to the Aurora Avenue North Improvements – 165th to 205th project. Grants are applied for and received for specific capital improvements. The amount of capital grants received in any given year can vary greatly depending on the number of projects, their cost and the amount of grant funding available.

Proposed Changes to City's Fee Schedules

As prescribed in Shoreline Municipal Code (SMC) 3.01.080 fees shall automatically be updated annually by the July to June Seattle-Tacoma-Bremerton Consumer Price Index for all urban consumers (CPI-U). This index equaled an increase in the CPI-U of 3.15%.

Land Use & Non-Building Permit Fees

The land use and non-building permit fees are based on an hourly rate. The hourly rate will increase from the current rate of \$145 to \$149.50 based upon the increase in the CPI-U. Building permit fees are based on the value of construction. Therefore, inflationary increases or decreases in valuation are automatically taken into account within the fee calculation. Plan check fees are based on the building permit fee and therefore no adjustment is needed to these fees. There is one new fee being proposed in this category: Administrative Design Review which will be charged at the same \$149.50 per hour with a three hour minimum charge of \$448.50.

Recreation Fees

This category includes fees for recreation classes, facility rentals, swimming lessons, drop-in fees and fees for other recreational activities. The proposed fee schedule includes no changes for 2012.

Surface Water Utility Fees

Surface water utility fees are proposed to increase by 2.5%. This will result in the annual single-family residential rate increasing from \$130.20 to \$133.46. The current fee has been in place since 2009. Multi-family and commercial users are charged at a rate that reflects the area of impervious surface. These rates will also increase by 2.5%.

License and Public Record Fees

License fees, the hearing examiner fee and public records fees such as photocopying and obtaining recordings and publications on DVD or CD will increase by 3.15% where applicable.

Work Release Defendant Fees

Staff is proposing the SMC 3.01.055 Work Release Defendant fee be repealed. This fee was established in 2009 to collect fees from inmates participating in the King County work release program. This fee is no longer necessary as Snohomish County collects fees directly from inmates participating in the work release program and therefore credit the daily housing fee charged to the City of Shoreline.

Solid Waste Fees

The City contracts with CleanScapes to provide solid waste (garbage) services to the Shoreline community. The contract with CleanScapes provides for annual adjustments to the collection service charges based on a composite index or three indices that measure changes in inflation, fuel, and labor costs.

The three indices used to calculate the composite change in service collection fees and their respective weights are:

- 1. The first-half annual consumer price index for Urban Wage Earners and Clerical Workers for the Seattle-Tacoma-Bremerton (CPI-W) (June to June) 42%
- 2. Energy Information Agency annual West Coast Retail October through September) 8%
- 3. Employment Compensation Cost Index for Private Industry for service providing industries (June to June) 50%

The resulting composite change using this formula is 4.31% for 2012. This increase applies only to the service or collections component of the garbage rates. The disposal component of the garbage fees are not changed by this index, but rather are based on costs from King County per ton disposal charge, the Local Hazardous Waste Management Program (LHWMP) surcharge and the State refuse tax. Both the County disposal fee and the LHWMP surcharge will increase starting in January 2012, which will in turn increase the State tax amount.

The resulting overall average increase in weekly service rates for residential customers is 7.58% and for weekly service rates for commercial and multi-family rates is 7.06%. Adjusted rates become effective on March 1st of the following year with customers being notified no later than January 15th, forty-five (45) days prior to the effective date of the new rate. There will be an additional one-time disposal charge applied to the March 2012 service cost for the January and February fee increases as shown in Attachment A. The solid waste rates are being incorporated into the City's fee schedule. CleanScapes, as the contractor for the service, is responsible to collect the fees.

Classification and Compensation Plan

In July 1997, Council approved the City's Classification and Compensation Plan. The plan established a comprehensive set of classification specifications for the work performed by City employees, and based on the City's adopted job market, established appropriate competitive salary ranges for these classifications.

The goals of the City's Compensation Plan are to:

- Ensure the City has the ability to attract and retain well-qualified personnel for all job classes:
- Ensure the City's compensation practices are competitive with those of comparable public sector employers;
- Provide defensibility to City salary ranges based on the pay practices of similar employers; and
- Ensure pay consistency and equity among related classes based on the duties and responsibilities assumed

The Plan established a policy of paying at the median of the market of the City's comparable jurisdictions. We compare salaries at the top of the salary range. If the City's salary is within five percent, above or below, of the market median salary than we consider the salary to be at market.

Results of the 2011 Salary Survey

This year staff surveyed the classifications in the top third of the City's salary ranges. There are no recommended changes as a result of the survey: all classifications surveyed this year were determined to be within market. The results of the survey confirm that the Council's Classification and Compensation Plan and the policy to resurvey the classifications on a regular basis work well in establishing and maintaining equitable, competitive, reasonable salaries for City employees, as currently defined by our compensation program.

Annual Cost of Living Adjustment (COLA)

The proposed 2012 budget included a cost of living adjustment of 2.04%. The City has not given employees a cost of living adjustment (COLA) since 2008, as a result of negative inflation. In calculating a recommended COLA for 2011 staff compared the change in CPI-U from June 2008 to June 2011 (2.27%). The City's policy has been to give a COLA of 90% of the change in inflation, resulting in a 2012 recommended COLA adjustment of 2.04%. The 2012 budget includes just over \$200,000 in additional salary cost as a result of the recommended 2.04% COLA. This represents 1.8% of the total budgeted salaries for 2012. In addition to the salary impact the COLA results in \$29,521 increase in related benefit costs (i.e., social security replacement, medicare contribution, and state retirement contribution).

Staff has also surveyed the City's comparison cities to determine the COLA included in their proposed 2012 budgets. The chart below details the results of that survey. The median proposed COLA of our comparable cities is 1.75%.

There are two types of service charges: The flat rate and the sliding rate.

- * The flat rate service charge of \$130 a year applies to single family homes and parcels with less than 10% impervious surface.
- * The sliding rate service charge applies to all other properties in the service area. The sliding rate is calculated by measuring the amount of impervious surface on each parcel and multiplying the appropriate rate by total acreage

Several special rate categories will automatically be assigned to those who qualify.

- * An exemption for any home owned and occupied by a low income senior citizen determined by the assessor to qualify under RCW 84.36.381.
- * A discount for any parcel served by a City approved retention/detention (R/D) facility maintained by the owner.
- * A discount for any parcel, or part parcel officially designated as open space.

* Mobile Home Park Assessment can be the lower of the appropriate rate category or the number of mobile home spaces multiplied by the single-family residential rate.

Rate Adjustments: Any person receiving a bill may file a request for a rate adjustment within two years of the billing date. (Filing a request will not extend the payment period).

Property owners should file a request for a change in the rate assessed if:

- * The property acreage is incorrect;
- * The measured impervious surface is incorrect;
- * The property is charged a sliding fee when the fee should be flat;
- The person or property qualifies for an exemption or discount; or
- * The property is wholly or in part outside the service area.
