#### 8. ACTION ITEM: PUBLIC HEARING

(a) Public hearing to receive citizens' comments on Resolution No. 341, Supporting the Countywide Ballot Proposition for Reauthorizing the Medic One/Emergency Medical Services (EMS) Levy for the period from January 1, 2014 through December 31, 2019

The staff report was provided by Scott MacColl, Intergovernmental Program Manager, Jim Fogerty, King County Emergency Medical Services Region Director, and Mark Bunje, Shoreline Fire Chief. Mr. MacColl outlined the proposal to pass a resolution supporting the continued funding of the countywide EMS system. Mr. Fogerty explained the EMS system as a regional, tiered model composed of both Basic Level Service (BLS) and Advanced Level Service (ALS). He provided statistics on U.S. outcomes and described the strategic planning process, which began in 2011 with the EMS Levy Advisory Task Force. He concluded by discussing regional services and the distribution of costs, Chief Bunje discussed the efficiencies of the EMS system.

#### Mayor McGlashan opened the public hearing.

a) John Kennison, Shoreline Fire Commissioner, urged the City to support the EMS Levy and pass the resolution.

# Seeing no one else wishing to provide comment, Mayor McGlashan closed the public hearing.

9. ACTION ITEM

(a) Adoption of Resolution No. 341, Supporting the Countywide Ballot Proposition for Reauthorizing the Medic One/Emergency Medical Services (EMS) Levy for the period from January 1, 2014 through December 31, 2019

**Councilmember Winstead moved adoption of Resolution No. 341. Councilmember Salomon seconded the motion.** Councilmembers spoke in favor of the motion and discussed heart attacks, cardiac arrest, and other various medical issues. There were favorable comments about the EMS system, medical advances, best practices, and the efforts of the Task Force.
