## PROBLEM/ISSUE STATEMENT:

The terms of the following three Planning Commissioners will expire on March 31, 2014:

- Michelle Wagner
- Donna Moss
- Cynthia Esselman

The four members of the Planning Commission whose terms are not up this year are Keith Scully, David Maul, Easton Craft, and William Montero.

The rules for Planning Commission Membership in the Shoreline Municipal Code (SMC 2.20.020(A)) state: "...No member shall serve longer than two consecutive terms". Since Michelle Wagner has already served two consecutive terms, she is not eligible for reappointment to the Commission. The two other Commissioners whose terms expire this year, Donna Moss and Cynthia Esselman, are eligible for reappointment.

### BACKGROUND:

The three vacancies on the Commission were advertized starting November 16, 2013 with the application period closing January 31, 2014. The City notified the public of these openings through Currents, the City's webpage, Shoreline Area News, Planning Commission Agenda Email (Constant contact), Shoreline E-News (Patch), Channel 21, City Manager's Report to Council, Facebook, Twitter, and the Council of Neighborhoods January meeting. A notice was also posted at the Shoreline Libraries, Police Station, Neighborhood Centers, and Spartan Recreation Center. At the close of the application period, 15 applications were received.

Subsequent to the advertising of these positions, the Mayor appointed a subcommittee to screen, interview and make recommendations to the full Council about which candidates to appoint. The subcommittee included Deputy Mayor Eggen, and Councilmembers Hall and Roberts. The subcommittee met on February 8, 2014 to determine which of the 15 candidates to interview. From this group of 15 candidates, the subcommittee selected seven to interview (shown with asterisks):

On February 22, 2014, the subcommittee conducted the interviews with the seven applicants. Following the interviews and subcommittee deliberation, the subcommittee unanimously recommended that the full Council appoint Donna Moss, Jack Malek, and Terri Strandberg to the Planning Commission.

## **RECOMMENDATION**

Staff recommends that the Council accept a motion to appoint Donna Moss, Jack Malek, and Terri Strandberg to the Planning Commission for 4-year terms that will run from April 1, 2014 through March 31, 2018.

My current employer is an 81 year-old man with significant disabilities who hired me to be his personal manager. This position allows me to remain professionally engaged as a volunteer and/or paid consultant in the area I am most passionate about, and believe is critical to our country's future: Growing Transit Communities.

In 1992, King County Metro hired me as a Fiscal Specialist and successively promoted me to a Senior Transportation Planner. Based on my accomplishments, resulting in KC Metro savings of more than \$1M in 2007, Washington Metropolitan Area Transit Authority (WMATA) in Washington DC recruited me as the founding director of a new office to overhaul the Authority's bus and paratransit eligibility process for seniors and people with disabilities. In 2012, WMATA won the American Public Transit Authority (APTA) Innovation Award for programs I established.

- 3. Describe your involvement in the Shoreline community.
  - •<u>Member of the Westminster Triangle Neighborhood Network since inception, where my</u> first leadership role was the New Neighbor Coordinator. When someone new moved in,

either the block coordinator or myself visited the new household to introduce ourselves and the Triangle Network, and to provide a Welcome Packet with free bus passes and schedules for the area, as well as other helpful where-to-turn information. Shoreline had not yet been incorporated.

- Beginning in 1992, I led volunteers in a neighborhood project to renovate an area owned by City Light into a public garden at Linden Avenue North and North 145<sup>th</sup>, which subsequently became the city-owned garden at the Interurban trailhead. In addition to drafting volunteers and soliciting donations, I applied and administered a matching minigrant, to install improvements in the community garden through the joint efforts of neighbors and other volunteers. Our community project received an award by the City for achieving stated goals and improving the neighborhood with our project.
- In 2007, I worked on traffic mitigation project with other neighbors, led by John Marek from Shoreline. After meeting with representatives from the police and fire departments, and walking the entire neighborhood noting concerns, the group identified ways to improve walkability and safety for pedestrians. Following a public meeting for the neighborhood to gather input, the team recommended methods to reduce cut through traffic and speeding in neighborhood via traffic circles, an island at intersection of Westminster Way and N. 150<sup>th</sup>, and stenciling speed limits on road. Since then, in addition to the recommendations, chicanes were installed along Evanston, which significantly reduced traffic speed and volume
- 4. Describe your leadership roles and/or any special expertise you have which would be applicable to the position for which you are applying. <u>Currently a City of Shoreline Planning Commissioner, I was elected chair in 2012, and re-elected chair in 2013. Under my leadership, the Commission completed the comprehensive plan update within one year; established a Light Rail Committee in 2012 with three of the newly appointed commissioners, which has increased public interaction with the Commission, and addressed other issues related to the SMC. I have performed various leadership roles throughout my lifetime. Please see response to question 3 and attached resume for more information.</u>

While working in DC, I specifically chose to live in the Village of Friendship Heights, a neighborhood in Chevy Chase, MD, which is one of the most densely populated urban census tracts in the nation. The Village encompasses less than one square mile in area, yet has many housing units. Friendship Heights demonstrated the balance between housing density, abundant trees and green space, business development, and exemplified effective transit oriented development. This experience strongly aligns with my dedicated interest in smart growth planning and development.

With at least one vacancy on the Commission, my reappointment will provide historic context and continuity for the Commission. Sound Transit's designation of two light rail stations in

Shoreline provides a prime opportunity to serve my city by drawing on my background as a senior transportation planner as well as doing what I love most: planning vibrant transit oriented communities. I recognize the need to accommodate density while maintaining vital single-family neighborhoods. To accommodate the needs of an aging population, we need strong community infrastructure that provides services people need in close proximity to their homes. Although cars will always be part of our landscape, better public transit and walkability are important facets of accomplishing vibrant neighborhoods. It is my pleasure to serve the city for the next four years to advance the goals and objectives of the Comprehensive Plan.
