PROBLEM/ISSUE STATEMENT:

Staff is requesting that Council authorize the City Manager to execute a contract with AECOM Technical Services, Inc. for inspection services on the Meridian Avenue N and N 155th Street Intersection Phase Changes Project in the amount of \$93,295. This project will upgrade the traffic signal and curb radii and update the curb ramps at the intersection of Meridian Avenue N and N 155th Street to address left-turning collisions and increase pedestrian safety. The intersection pavement will also be rehabilitated.

Due to increased development activity and the start of the construction phase for the Sound Transit Lynwood Link Extension project, City Construction Inspectors are not available to provide inspection services for a project of this size. Therefore, contract inspection services are needed to complete this project. AECOM Technical Services, Inc. has been selected as the most qualified firm to support the City with this project through the construction phase and staff have negotiated a contract to provide Inspection Services. Council authorization is needed to enter into an agreement with AECOM Technical Services, Inc.

RESOURCE/FINANCIAL IMPACT:

The Meridian Avenue N and N 155th Street Signal Improvements project is funded with a combination of grant funds and funds from the Annual Road Surface Maintenance program, the Traffic Signal Rehabilitation project and the Roads Capital Fund. Below is a breakdown of the approved 2019 budget that will deliver this project:

The project budget shortfall is attributable to higher-than-anticipated bid results and staffing constraints that will require utilizing contracted services for construction inspection and administration. Additional resources to deliver the project are available from fund balance within the Roads Capital Fund. The fund balance comes primarily from the surplus of approximately \$796,000 of Shoreline Transportation Benefit District (TBD) revenue that can be programmed for the Annual Road Surface Maintenance Program, thereby making available \$457,571 of Roads Capital fund balance which can be allocated to fill the shortfall for this project.

A budget amendment is not required at this time as these changes remain within the authorized expenditures for the Capital Improvement Program (CIP). The adjusted project revenue is as follows:

BACKGROUND

The Meridian Avenue N and N 155th Street Intersection Phase Changes Project is included in the 2019-2024 CIP. To address at-angle collisions at this intersection, this project will replace span wires and signals with new poles and mast-arms with capacity to add flashing yellow arrow signal indications for northbound left turns and southbound left turns.

The project will also include replacements of junction boxes, conduits, signal cabinets, detection loops, and signal controller. Additionally, the project will decrease intersection curb radii to lower vehicle turning speeds and reduce pedestrian crossing distance. This will increase pedestrian safety and provide vehicle and bicycle detection where needed. The intersection sidewalks, curb ramps and pedestrian signal system will be upgraded for ADA compliance and the intersection pavement will be rehabilitated as part of this project.

DISCUSSION

On March 4, 2019, the City issued a Request for Qualifications (RFQ) for establishment of a Construction Services Roster. Five firms submitted Statements of Qualifications (SOQ's), which were reviewed by staff. Four firms were selected for final consideration and AECOM Technical Services, Inc. was subsequently selected as the most qualified for this project.

The alternative to not authorizing this contract is utilizing current staffing resources either by re-prioritizing other work or delaying the project until staffing resources become available, which is not recommended. The construction contract has been awarded and delaying the contract would result in potential claims from the Contractor. Current staff are fully utilized on other construction projects including private development, the Sound Transit Lynnwood Link Extension Project, and other capital projects. If the project is delayed indefinitely, the project would risk forfeiting the federal grant funding, including the return of federal funds received for the design phase of the project. Construction of the Project is anticipated to start in June 2019 with final completion anticipated by November 2019.

Staff is therefore requesting that Council authorize the City Manager to execute a contract with AECOM Technical Services, Inc. for inspection services on the Project in the amount of \$93,295. Council authorization is needed to enter into an agreement with AECOM Technical Services, Inc.
