**PROBLEM/ISSUE STATEMENT:**

On July 29, 2019, the City Council adopted Ordinance No. 866, placing a general obligation bond measure for parks, recreation, and open space improvements on the November 5, 2019, general election ballot. For the primary and general election, King County publishes a voters' pamphlet. Cities placing measures on the ballot are automatically included in the voters' pamphlet.

The City Council is responsible for appointing committees to prepare statements in favor of and in opposition to a ballot measure. These statements will be published in the voters' pamphlet. Council must select Pro Committee members from persons known to advocate for voters' approval of Proposition 1. They must select Con Committee members from persons known to advocate voters' rejection of Proposition 1. There is a limit of three members per committee. The committee appointments must be filed with King County by August 6, 2019. This evening the City Council will make those appointments.

Staff started advertising for members to serve on both the Pro and Con Committees on Tuesday, July 16, 2019. Staff made information available on the City's website and provided information to *Shoreline Area News* and neighborhood leaders. Staff also posted to the City's Facebook and Twitter accounts and sent the posting through the City's e-notification system. Applications for the committee appointments were due August 2, 2019 at 10:00 a.m. This was a staff-imposed deadline so staff would have time to produce this staff report and make it available to the Council and public by Friday, August 2, ahead of tonight's meeting.

The committees are responsible for writing statements in favor of or in opposition to the ballot measure. These statements must be submitted to King County Elections no later than August 13, 2019, and are limited to 200 words. Each committee must submit their rebuttal statements to King County no later than August 15, 2019. Rebuttal statements are limited to 75 words.

The City must also provide an explanatory statement of the ballot title for the voters' pamphlet. The statement describes the effect of the measure if it is approved and is not to intentionally be an argument likely to create prejudice either for or against the measure. The explanatory statement is limited to 250 words, must be signed by the City Attorney, and submitted to King County Elections by August 9, 2019. Although the Council does not need to take any action on the explanatory statement, a draft of the explanatory statement is included as Attachment B.

**RESOURCE/FINANCIAL IMPACT:**

There is no resource or financial impact to appoint the Pro and Con Committees for City of Shoreline Proposition 1.

**RECOMMENDATION**

The City Council of the City of Shoreline adopted Ordinance No. 866 concerning a new aquatic and community center and neighborhood park improvements. This proposition authorizes the City to acquire property and construct an aquatic and community center for senior, youth, and family activities, including classroom/exercise space, recreation/lap pools, gymnasiums, indoor walking/jogging track, and a commercial kitchen; construct park amenities, playgrounds, splash-pads, and/or trails in parks; issue up to \$103,600,000 of general obligation bonds maturing within 20 years to finance and refinance such projects; and levy annual excess property taxes to repay such bonds, as provided in Ordinance No. 866.

**EXPLANATORY STATEMENT**

If approved by Shoreline voters, this proposition authorizes the construction of the Shoreline Aquatics, Recreation, and Community Center (ShARCC) and improvements to four neighborhood parks.

The ShARCC would replace the almost 50-year-old Shoreline Pool and the 70 plus year-old Spartan Recreation Center.

The proposed ShARCC is expected to be approximately 75,000 square feet and include:

- Space for classes/rentals/gatherings.
- 6,000 square feet of space prioritized for senior programs, including a commercial kitchen.
- Gymnasium.
- Indoor walking/jogging track.
- Exercise/weight rooms.
- Activity pool with play features.
- Separate eight-lane lap pool for: recreational and competitive swimming and diving; swim lessons; and shallow and deep-water exercise classes.
- ADA accessible pool viewing area for 500 spectators.
- Outdoor play/gathering area.

The four neighborhood parks that will get improvements are: Brugger's Bog, Hillwood, Richmond Highlands, and Briarcrest Community Park (Hamlin East). Park improvements include such things as playgrounds, splash-pads, multi-sports courts, trails and a fully accessible play area for people of all physical abilities.

If approved, Proposition 1 will authorize the City to issue up to \$103,600,000 in general obligation bonds to finance and refinance these projects, including the acquisition of land, and set excess property taxes to repay those bonds. The bonds would mature within 20 years. Although the exact amount of property taxes per household necessary to repay the bonds will depend on interest rates and property values, the City estimates the additional annual property tax rate for the owner of a median valued home (\$480,000) would be \$244 per year, or \$20 per month.
