#### PROBLEM/ISSUE STATEMENT:

In 2011, the City Council adopted a Healthy City Strategy Work Plan that included a goal of making all of Shoreline's parks and public sites a tobacco-free zone. In 2012, the City Council adopted Ordinance No. 630 which prohibited tobacco use in any Shoreline park area so as not to send the message that using tobacco products is consistent with a healthy environment and a healthy lifestyle given the fact that Shoreline's parks are intended for the healthy enjoyment of all citizens, including children. Shoreline Municipal Code (SMC) Section 8.12.395 implements Ordinance No. 630.

Since the adoption of Ordinance No. 630, the popularity of electronic cigarettes (ecigarettes; vaping) has grown, especially in middle school and high school-aged youth, to epidemic levels. The Surgeon General has also stated that e-cigarettes can potentially expose bystanders to harmful substances, including heavy metals, volatile organic compounds, and ultrafine particles that can be inhaled in the lungs.

Tonight, Council will discuss proposed Ordinance No. 867, which would amend SMC Section 8.12.395. This amendment would include e-cigarettes within SMC 8.12.395's prohibition, continuing the message of Ordinance No. 630 that the use of e-cigarettes is not consistent with a healthy lifestyle. Proposed Ordinance No. 867 is currently scheduled to be brought back to Council for adoption on October 7, 2019.

#### FINANCIAL IMPACT:

There will be negligible financial impact for replacement of signs associated with this Ordinance.

## RECOMMENDATION

No action is required tonight; this item is for discussion purposes only. When this item is brought back to Council for potential adoption, staff recommends that Council adopt proposed Ordinance No. 867.

## BACKGROUND

In 2011, the City Council adopted a Healthy City Strategy Work Plan that included a goal of making all of Shoreline's parks and public sites a tobacco-free zone. In March 2012, the City Council adopted Ordinance No. 630, prohibiting tobacco use in any Shoreline park area so as not to send the message that using tobacco products is consistent with a healthy environment and a healthy lifestyle, given the fact that Shoreline's parks are intended for the healthy enjoyment of all citizens, including children. Shoreline Municipal Code (SMC) Section 8.12.395 implements Ordinance No. 630. The staff report for adoption of Ordinance No. 630 is available at the following link: Adoption of Ordinance No. 630 – Tobacco Free Park Regulations.

Since the adoption of Ordinance No. 630 in 2012, the popularity of electronic cigarettes (e-cigarettes, vaping) has grown, especially in middle school and high school-aged youth, to epidemic levels. Staff have also noticed an increase in e-cigarette and vaping usage in parks and in recreation facilities in recent years.

The Center for Disease Control and Prevention (CDC) and the Surgeon General have issued advisories on e-cigarette use among youth because the presence of nicotine in e-cigarettes can harm brain development in children, teens, and young adults, impacting learning, memory, and attention. Other concerns with e-cigarettes include the increased risk for future addiction to other drugs and injury from combustive battery failures. The Surgeon General has also stated that e-cigarettes can potentially expose bystanders to harmful substances, including heavy metals, volatile organic compounds, and ultrafine particles that can be inhaled in the lungs.

#### DISCUSSION

Tonight, Council will discuss proposed Ordinance No. 867 (Attachment A), which would amend SMC Section 8.12.395. This amendment would include e-cigarettes within SMC 8.12.395's prohibition of smoking and tobacco use in parks. Including e-cigarettes and vaping in the prohibition of tobacco use in City parks is consistent with the City Council's intent to encourage a healthy lifestyle when Ordinance No. 630 was adopted. State law (RCW 70.345.210) grants the City authority to regulate the use of vapor products in outdoor public places where children congregate, such as playgrounds and parks; and may regulate the use of vapor products in indoor public places subject to RCW 70.345.150.

Staff are not aware of enforcement issues or concerns with the current prohibition of tobacco use in the park system. Parks staff and administrators would continue to rely on education and 'peer to peer' enforcement as the predominant enforcement mechanism, as has been done effectively with the enforcement of the current prohibition. Park signs would also be modified where appropriate to make park visitors aware that vaping and e-cigarette use is prohibited.

Proposed Ordinance No. 867 is currently scheduled to be brought back to Council for adoption on October 7, 2019.

## FINANCIAL IMPACT

There will be negligible financial impact for replacement of signs associated with this Ordinance.

#### RECOMMENDATION

No action is required tonight; this item is for discussion purposes only. When this item is brought back to Council for potential adoption, staff recommends that Council adopt proposed Ordinance No. 867.

#### **ORDINANCE NO. 867**

#### AN ORDINANCE OF THE CITY OF SHORELINE, WASHINGTON, AMENDING SECTION 8.12.395 OF THE SHORELINE MUNICIPAL CODE TO INCLUDE E-CIGARETTES (VAPING) AS PROHIBITED ACTIVITIES.

WHEREAS, e-cigarettes are battery-operated inhalers containing nicotine, where the battery heats liquid in a cartridge, turning into vapor that can be inhaled, and the process of inhaling e-cigarette liquid is often called vaping; and

WHEREAS, in 2011, the City Council adopted a Healthy City Strategy Work Plan that included a goal of making all of Shoreline's parks and public sites a tobacco-free zone; and

WHEREAS, in 2012, the City Council adopted Ordinance No. 630, prohibiting tobacco use in any Shoreline park area so as not to send the message that using tobacco products is consistent with a healthy environment and a healthy lifestyle given the fact that Shoreline's parks are intended for the healthy enjoyment of all citizens, including children; and

WHEREAS, in 2016, the Washington State Legislature adopted comprehensive legislation relating to youth vapor product substance use prevention and vapor product regulation, creating RCW Chapter 70.345 Vapor Products and amending other chapters of RCW Title 70 Public Health and Safety, including chapter 70.155 Tobacco – Access to Minors and chapter 70.160 Smoking in Public Places; and

WHEREAS, since the adoption of Ordinance No. 630, the popularity of electronic cigarettes (e-cigarettes) has grown, especially in middle school and high school-aged individuals, to epidemic levels; and

WHEREAS, the Center for Disease Control and Prevention (CDC) and the Surgeon General have issued advisories on e-cigarette use among youth because the presence of nicotine in e-cigarettes can harm brain development in children, teens, and young adults impacting learning, memory, and attention along with increasing the risk for future addiction to other drugs and injury from combustive battery failures; and

WHEREAS, the Surgeon General has also stated that e-cigarettes can potentially expose bystanders to harmful substances, including heavy metals, volatile organic compounds, and ultrafine particles that can be inhaled in the lungs; and

WHEREAS, RCW 70.345.210 grants the City authority to regulate the use of vapor products in outdoor public places where children congregate, such as playgrounds and parks; and may regulate the use of vapor products in indoor public places subject to RCW 70.345.150; and

WHEREAS, an amendment is needed to include e-cigarettes within SMC 8.12.395's prohibition, continuing the message of Ordinance No. 630 that the use of e-cigarettes is not

consistent with a healthy lifestyle;

# NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF SHORELINE, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Amendment to SMC 8.12.395. Section 8.12.395 is amended to read as follows:

SMC 8.12.395 Tobacco use in parks-Smoking Prohibited.

No person shall use tobacco in any park area. "Tobacco use" is defined as the smoking or lighting of cigarettes, cigars, or pipe tobacco, or the use of smokeless tobacco. Smoking and tobacco use of any kind, including but not limited to, the use of cigarettes, cigars, pipe tobacco, smokeless tobacco, and electronic or vaporized smoking devices, is prohibited in any City park area, trail, athletic field, or recreation facilities.

Section 2. Corrections by City Clerk or Code Reviser. Upon approval of the City Attorney, the City Clerk and/or the Code Reviser are authorized to make necessary corrections to this ordinance, including the corrections of scrivener or clerical errors; references to other local, state, or federal laws, codes, rules, or regulations; or ordinance numbering and section/subsection numbering and references.

**Section 3. Severability.** Should any section, subsection, paragraph, sentence, clause, or phrase of this ordinance or its application to any person or situation be declared unconstitutional or invalid for any reason, such decision shall not affect the validity of the remaining portions of this ordinance or its application to any person or situation.

**Section 4. Publication and Effective Date.** A summary of this Ordinance consisting of the title shall be published in the official newspaper. This Ordinance shall take effect five days after publication.
