ISSUE STATEMENT:

Every year, disasters and local emergencies disrupt the lives of thousands throughout the United States. Being prepared for such incidents can reduce fear, anxiety, and losses that might otherwise occur as well as help the community's resiliency to such events. Additionally, the vitality of our City depends on how safe and prepared we keep our homes, businesses, neighborhoods, and schools. Community members and business are encouraged to implement personal and community preparedness and crime prevention measures as well as participate in City sponsored programs such as the Community Emergency Response Team (CERT), the Shoreline Auxiliary Communications Service (ACS), Shoreline Watch, and RADAR.

To highlight emergency preparedness, the month of September has been declared "National Preparedness Month". To remind our citizens to stay vigilant about community safety and crime prevention, the month of October has also been declared "National Crime Prevention Month".

Given the confluence of these awareness campaigns, the City is proclaiming the month of October as Safe Shoreline Month. This proclamation highlights the proactive and innovative work the City is doing in the areas of policing and emergency management programs to bring staff, police, and the community members together to focus on building trusted relationships in strong, prepared, and resilient neighborhoods.
