PROBLEM/ISSUE STATEMENT:

As we are all aware, September 11 is a date when all Americans will be reflecting on last year's tragic events and commemorating the sacrifices and heroism of that day. Across the state and the nation, various activities are planned to unite all our citizens in recalling and honoring those involved.

On June 10, 2002, Deborah Todd came to the City Council meeting and asked for Council support for a group of Shoreline citizens planning to emphasize the strength and unity of our community as the appropriate tribute to the events of September 11. Ms. Todd also asked that the Mayor and Council proclaim September 11, 2002 as "A Day of Unity" in Shoreline as part of a slate of activities planned to observe this anniversary.

The "Day of Unity" proclamation asks Shoreline citizens to observe the first anniversary of September 11 by focusing not on the issues that divide us, but on the things that bring us together as a human family. Ms. Todd, or a member of her group, will be present at the Council meeting to accept the proclamation.
