<b>AGENDA TITLE:</b>	Motion to Authorize the City Manager to Execute a Construction Contract with the lowest bid contractor for the 175 <sup>th</sup> Street Sidewalk (Meridian to Corliss Avenues) Project and the 175 <sup>th</sup> Street Sidewalk (Adjacent to the YMCA) Project.

**PROBLEM/ISSUE STATEMENT:** Staff is requesting that Council authorize the City Manager to execute a construction contract with the lowest bid contractor for the 175<sup>th</sup> Street Sidewalk (Meridian to Corliss Avenues) Project and the 175<sup>th</sup> Street Sidewalk (adjacent to the YMCA) Project. Staff is requesting Council approval at this time in order to complete the project by December 31, 2002 to utilize construction Transportation Improvement Board (TIB) grant funding approved for this project.

The 175<sup>th</sup> Street Sidewalk (Meridian to Corliss Avenues) Project scope of work includes designing and constructing standard curb, gutter and sidewalk with railing and minimal storm drainage improvements along 175<sup>th</sup> Street from Meridian Avenue to Corliss Avenue. This project would connect existing sidewalks for a continuous flow from Meridian Avenue to Corliss Avenue and provide safe travel for pedestrians accessing the bus stop, the elementary school and the church.


The 175<sup>th</sup> Street Sidewalk (adjacent to the YMCA) Project scope of work includes designing and constructing new concrete curb, gutter and eight (8) foot wide sidewalks, driveway aprons, and storm drainage adjustments. In addition, it includes Americans with Disabilities Act (ADA) improvement ramps on the north side of NE 175<sup>th</sup> Street between 15<sup>th</sup> Avenue NE and the YMCA. This project would connect existing sidewalks for continuous flow along 175<sup>th</sup> Street to 15<sup>th</sup> Avenue NW.

Due to the need to complete this project by the end of 2002, the project bids were received and opened on September 23, 2002. Therefore, staff will be bringing the name of the recommended lower bidder and the actual amount of the recommended contract to tonight's Council meeting.

**FINANCIAL IMPACT:** The 175<sup>th</sup> Street Sidewalk (Meridian to Corliss Avenues) Project is identified in the City's 2002 CIP and includes a total project budget of \$186,285. This project also includes a TIB grant in the amount of \$126,652 for construction work on this project. The 175<sup>th</sup> Street Sidewalk (adjacent to the YMCA) Project is also identified in the City's 2002 CIP and includes a total project budget of \$116,000. This project also includes a TIB grant in the amount of \$52,000 for construction work on this project.

### **RECOMMENDATION**

Staff will present the bid results at the City Council meeting. If bids are within available resources, staff will recommend that Council authorize the City Manager to execute a construction contract with lowest bid contractor to complete the 175<sup>th</sup> Street Sidewalk Project (Meridian to Corliss Avenues) and the 175<sup>th</sup> Street Sidewalk (Adjacent to the YMCA) Project.
