AGENDA TITLE:	Conduct a Public Hearing to Consider the Human Service Allocation Committee Recommendations for the 2003-2004 Human Services Funding Plan (Including General Fund and Community Development Block Grant) and Authorize the City Manager to Sign the Contracts Implementing Approved Recommendations.

PROBLEM/ISSUE STATEMENT: Council has an established role to approve the funding levels for the competitive human service funding process (both General Fund and Community Development Block Grant). In addition, the Community Development Block Grant program requires that Council hold a public hearing in regards to the proposed use of these funds.

ALTERNATIVES ANALYZED: After holding a public hearing on the proposed 2003/2004 Human Services Funding Plan, Council has two alternatives to consider:

1. Council could take action to approve the 2003/2004 Human Services Allocations Plan for services and capital projects as recommended by the Human Services Allocation Committee and authorize the City Manager to take the actions necessary to implement these spending objectives. (Recommended)
2. Council could make changes to the recommended spending plan in response to public testimony or to reflect a change in Council policy objectives.



FINANCIAL IMPACT: Historically, the City of Shoreline has budgeted \$183,000 in General Funds (including the Youth Policy Funds) for this competitive process each year. The other source of funding for human services is Community Development Block Grant (CDBG) funding, which is estimated to be \$57,941 for each year. In addition, we estimate that the City will receive \$39,239 each year to administer the CDBG program.

For the Capital Project and the Home Repair Program, while within the City's control to allocate, King County fiscally and programmatically manages those funds on our behalf.

RECOMMENDATION

Staff recommends that Council hold a public hearing and adopt the Human Services Allocations Committee's recommended 2003/2004 Human Services Funding and Contingency Plan and the recommended allocations for CDBG Planning/Administration and the King County Housing Repair Fund; and authorize the City Manager to enter into agreements for implementing these projects. These funding levels are contingent on

the passage of the City of Shoreline 2003 and 2004 budget, as well as the passage of the Federal budget.

INTRODUCTION

This year's Human Services Funding and Contingency Plan covers two year's worth of funding, 2003 and 2004, for service projects, and one year, 2003, for capital projects. In addition, each year the Council must hold a public hearing on the proposed use of Community Development Block Grant (CDBG) funds and take action to adopt the allocation. CDBG funding is proposed to be used for Planning & Administration, Housing Repair, Public Services and Capital Projects. The recommended Human Services Funding and Contingency Plan is found in Attachment A and detailed project descriptions can be found in Attachment B.

BACKGROUND

Human Services Funding

Human Services funding includes both General Funds and Community Development Block Grant (CDBG) funding. The total available dollars for competitive allocation are approximately as follows:

Community Development Block Grant (CDBG) Funding

The primary objective of the Community Development Block Grant (CDBG) program is the development of viable urban communities, by providing decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low- and moderate-income. CDBG funds can be used for the following activities: delivery of human services; acquisition and rehabilitation of housing for low-income and special needs populations; housing repair for homeowners and renters; acquisition and rehabilitation of community facilities; public infrastructure improvements; historic preservation; planning; CDBG program administration; and economic development. CDBG funds can serve households with incomes up to 80% of the King County median income.

As an entitlement community under the regulations of the federal Department of Housing and Urban Development (HUD), Shoreline determines the allocations to eligible projects according to locally developed policies and the King County Consolidated Housing and Community Development Plan. For 2003 and 2004, the Human Services Allocations Committee selected the most feasible projects that best addressed local needs and purposes while supporting the Human Services Strategy; "15 Desired Outcomes" and the "Capital Project Priorities" (Attachment C).

HUD has not yet confirmed the 2003 or 2004 fiscal year budget. The following figures represent a close estimate of the CDBG funds that will be available to the City. These

funds will be confirmed or adjusted after the adoption of the Federal budget. For each year, 2003 and 2004, Shoreline's estimate of available CDBG funds is as follows:

1. Public (human) services*	\$ 57,941

* This amount represents the maximum CDBG funds that the City can allocate to public services, as determined by the CDBG Consortium.

**This amount represents the maximum allowable percentage for planning and administration under the Department of HUD regulations. In order to fund the administration of the City's CDBG program, this is the staff recommended funding level.

***In April, Council approved approximately \$155,000. During the allocations process, the Committee felt that they could both allocate adequate funds to the capital projects requesting funds, as well as put an additional \$15,918 in the Housing Repair Fund.

****This amount fully funds the Human Services Allocations Committee's recommendations for capital projects.

Application Process

In April, letters were sent to a list of over 80 "interested parties" announcing the availability of applications for Shoreline's 2003-2004 Human Service funds. An announcement of application availability was also placed in the Seattle Times and The Enterprise in April. A bidder's conference was held in conjunction with the North and East Funders Group.

A total of 30 applications were received by the application deadline of June 7, 2002. The City received 26 human services applications, totaling \$461,106 in requests. This exceeded the available funds by \$175,165. We received 4 capital project applications, totaling \$91,142 in requests, exceeding the available funding by \$49,793.

For comparison purposes, in 2000 the City received 21 public service requests and 4 capital project applications. The human services requests totaled \$283,162, exceeding the available funding of \$45,888. The capital project requests totaled \$175,793, exceeding the amount of available funds by \$49,793. In addition, \$155,000 in capital funds were allocated to the King County Housing Repair program.

Human Services Advisory Committee

In order to evaluate the 30 applications, a Human Services Allocations Advisory Committee was formed. The Committee had five community representatives. Community representatives were recruited through newspaper advertisements (Seattle Times, and Shoreline Enterprise), and posting on the City's web page. The advertisements outlined the following three requirements for serving on the Committee as a community representative:

1. Must be a resident of Shoreline;
2. Knowledge of or interest in human services, low-income or special needs housing, or other capital projects; and

3. Not currently employed by or a member of the Board of Directors of an agency which is applying for funds from the City.

The third requirement is used to avoid potential conflicts of interest.

Applicants were then asked to describe their educational and occupational background, their interest in serving on the Human Services Allocations Advisory Committee, and their involvement in the City of Shoreline. A total of 6 applications were received. Due to schedule conflicts, one of the six was unable to serve on the Committee. Staff reviewed the applications and forwarded their recommendations to the Mayor and Deputy Mayor for review and approval. The Committee members were appointed in early June. Five applicants were chosen and able to serve on the Advisory Committee:

1. **Raymond Hummel** has both grant writing and program administration experience. He is currently a self-employed grantwriter. Mr. Hummel has a strong interest in human services and wanted to be more involved in the community where he lives.
2. **Scott Keeny** has been a resident of Shoreline since 1979 and has been involved in many ways in the Shoreline community including the Richmond Beach Community Council, the Public Services Incorporation Committee, and the Shoreline/Lake Forest Park Arts Council. Mr. Keeny is currently a Fire Commissioner for the Shoreline Fire Department. This is his 4th time serving in this capacity.
3. **Edith Loyer Nelson** has lived in Shoreline for 33 years. She is currently employed by the State of Washington in the Native American Child Welfare Services Unit of the Division of Children and Family Services.
4. **Nancy Phillips** has lived in Shoreline for 42 years. She is retired and does volunteer work for elderly in their homes. Her work history includes experience as a substance abuse counselor.
5. **Dianne Ritter** has a masters of public health and works for Washington Dental Service and Washington Dental Service Foundation. In Shoreline, she has also participated and testified at meetings related to the Comprehensive Plan, North City Plan and other processes.

Review/Selection Process

The Committee met four times during July and August. Each member of the Committee reviewed all 30 applications. They independently reviewed each application prior to any discussion by the group. The Committee used Rating Criteria Sheets (Attachment D), which attached numerical values to questions for the purpose of assessing the following:

- Level of need for the proposed service in Shoreline;
- Whether the purpose of the service fits with the City's goals for human services;
- Ability to address at least one of the City's "Desired Outcomes" (Attachment C) and "Capital Project Priorities" (Attachment C);
- Level of collaboration and planning initiated by the applicant;
- Diversity of services and persons served;

- The financial and staffing feasibility of the applicant to successfully implement the project;
- Level of request in comparison to the level of service provided to Shoreline residents; and
- (Where applicable) An applicant's performance history on past contracts.

Any additional questions that the Committee had during their deliberations were noted by staff and the agencies were requested to provide information. Each member provided their scores for each project and the projects were then ranked. The rankings provide basis for discussing funding levels. A discussion on each project was held to answer questions, provide additional information, etc. Committee members were then able to revise their scores, and the rankings were revisited. Funding levels for the projects were then assigned, based on the overall rankings and the totality of the funding package.

Results

The Human Services Allocations Committee has reviewed and ranked the 30 applications for 2003-2004 CDBG/Human Services funding. The recommendations of the Committee have been summarized in the following list. A public hearing to solicit public comment will be held on September 23, 2002.

The Committee recommended 13 human service projects for funding in 2003/2004 and 4 capital projects for funding in 2003. The amounts listed refer to the amount that the City of Shoreline will enter into agreement with the agency for each year (2003 and 2004). More complete descriptions of each project can be found in Attachment B, along with brief descriptions of the Committee's rationale for its recommendation.

The Committee also developed funding contingencies as part of the 2003/2004 Human Services Funding and Contingency Plan. Due to the uncertainties in the federal budget process, the City must develop contingencies that allow for more or less funding. We are then able to adjust funding up or down without further applications or review.

After holding a public hearing on the proposed 2003/2004 Human Services Funding Plan, Council has two alternatives to consider:

1. Council could take action to approve the 2003/2004 Human Services Allocations Plan for services and capital projects as recommended by the Human Services Allocation Committee and authorize the City Manager to take the actions necessary to implement these spending objectives. (Recommended)
2. Council could make changes to the recommended spending plan in response to public testimony or to reflect a change in Council policy objectives.

SUMMARY

The Human Services Allocations Advisory Committee has met and reviewed 30 applications for Shoreline's 2003-2004 CDBG and Human Service funding (2003 and 2004 for service projects and one year, 2003, for capital projects). There were 26 applicants for human service projects and 4 applicants for capital projects. The Committee recommends funding 13 human service applicants for a total of \$240,941 and 4 capital project applicants for a total of \$66,142. A contingency plan was developed in case federal funds are either increased or decreased up to 10% from the

current estimates. The Committee's recommendation is based on a careful review and ranking of the applications through the use of the Rating Criteria Sheets.

RECOMMENDATION

Staff recommends that Council hold a public hearing and adopt the Human Services Allocations Committee's recommended 2003/2004 Human Services Funding and Contingency Plan and the recommended allocations for CDBG Planning/Administration and the King County Housing Repair Fund; and authorize the City Manager to enter into agreements for implementing these projects. These funding levels are contingent on the passage of the City of Shoreline 2003 and 2004 budget, as well as the passage of the Federal budget.

2003 Funding Contingency Plan

Since the CDBG funds are an estimate from the federal government, Shoreline must also adopt a contingency plan to deal with possible variations in the amount available. Plans must be made in case the amount available increases or decreases by up to 10% of the amount currently estimated. In addition, if an applicant later declines funds, the adoption of a contingency plan of action will expedite the process of reallocation.

a. Public Services

In the event CDBG Public Service funds are increased in 2003, the Committee recommends the following changes to the funding recommendations. Please note the changes in funding source that are necessary to implement the recommendations.

1. The first additional funds (up to \$2,500) would be provided to Senior Services of Seattle and King County – Meals on Wheels. In order to make these changes the following fund source change would be made.

2. After Meals on Wheels, the next \$4,000 of additional funds would be allocated to Hopelink's Family Development Program, as part of the Hopelink-Services Contract.
3. If any additional funds are available, the remainder of the funds will be allocated to the Center for Human Services.

b. Capital Projects

If additional CDBG Capital funds become available to the City in 2003, the Committee recommends awarding funds to the Home Repair Program.

c. Planning & Administration

First, If additional CDBG Planning & Administration funds become available to the City in 2003, it is recommended that the City use these funds for planning and administration purposes.

If funding reductions are necessary:

a. Public Services:
