- WHEREAS, many of this nation's soldiers lost their lives during wars to defend our freedom and some are still missing in action; and
- WHEREAS, there are more than 606,000 veterans in Washington State who have served our country with bravery and self-sacrifice ; and
- WHEREAS, on Saturday, November 11th the American Legion will join with the City of Shoreline in a brief ceremony at 2:00 p.m. at Hamlin Park to commemorate the contributions of the men and women in the military who served their country with courage and distinction and continue to serve their communities through veterans organizations;

Based on direction by your Council, the first Council workshop regarding the 2001 Proposed Budget will be held as part of the November 6 meeting. This workshop will consist of a series of presentations by City directors and managers concerning departmental and divisional budget proposals. As in past years, these presentations are designed to provide a brief overview of each budget section followed by Council questions and discussions. In the past few years there have been some departments for which the Council has had few questions (i.e. City Manager's Office). In order to expedite the budget review process and best use your Council's time these departments will not do a formal presentation but will be available to respond to your Council's questions. A second workshop is scheduled to begin prior to the regular November 13 meeting at the special time of 6:00 p.m. This workshop will cover the Public Works Department and the Capital Improvement Program. A third workshop is tentatively scheduled for 6:30 p.m. on November 20 in case it becomes necessary. The budget hearing is scheduled for the November 27 meeting at 7:30 p.m. Budget adoption is scheduled for the same meeting. The Mt. Rainier Room is reserved for all meetings. The meeting place, dates and times of each meeting have been advertised to inform our citizens.
