PROBLEM/ISSUE STATEMENT:

On October 10, 2003 from 1 – 5 p.m., the first Teen Skate Park event occurred at the Connie King Skate Park. The event was organized as a senior project by Shorecrest student Nick Louie. The event drew competitors aged seven to nineteen, with approximately 175 youth in attendance. Nick solicited sponsorships from community businesses, including Lost Boys Skate Shop, The Prime Skate Shop, BC Surf and Sport, and Central Market. These sponsorships provided \$1,500 worth of in-kind donations for prizes and give-aways. In addition to business sponsorships, Nick coordinated a free helmet give-away with the Shoreline Fire Department to raise safety awareness among the skaters.

Volunteers were crucial to the success of the event and Nick coordinated about ten volunteers who donated fifty hours, and Nick himself added another fifty hours of volunteering to ensure the success of the event.

Tonight Nick will be commended for his initiative and creativity in organizing Skate Jam 2003. It was an outstanding event for our young people that went off without a hitch due to Nick's planning and follow-through.
