PROBLEM/ISSUE STATEMENT:

The Interlocal Agreement with the City of Renton does not include annual adjustments for cost increases for services. The City of Renton's cost for providing the service have increased slightly, and they are requesting an addendum be executed to provide service in the future.

FINANCIAL IMPACT:

The financial impact for this addendum is estimated at \$1500 per year. The 2003 annual budget includes funds for this increase.

INTRODUCTION

The Interlocal Agreement with the City of Renton does not include annual adjustments for cost increases for services. The City of Renton's cost for providing the service have increased slightly, and they are requesting an addendum be executed to provide service in the future.

BACKGROUND

The interlocal agreement with the City of Renton signed last year does not include an annual adjustment procedure. As the result, an addendum to the interlocal agreement will need to be executed to continue providing this service.

While it would seem that a simple increase in costs would be an easy matter to handle administratively, as we manage to do for many of our contracts, we cannot do so with interlocal agreements. By state law, the City Manager does not have the ability to sign interlocal agreements for services without Council approval.

Analysis

As Council recalls, the City sends prisoners to the City of Renton to serve post-sentence jail sentences. Renton receives prisoners and makes them ready for transport later that day to Yakima County. In general, most prisoners serve less than 12 hours in Renton. For those prisoners who stay longer, the cost in increasing to \$58.80 from \$50. Staff estimates this to affect less than 170 prisoner days per year, making the overall annual fiscal impact around \$1500.

WHEREAS the cities named above have entered into an Interlocal Agreement (ILA) for the temporary housing of Shoreline's inmates by Renton; and

WHEREAS the ILA has a Payment Schedule in section 4; and

WHEREAS the amounts in the payment schedule were governed by the payment schedule of the Long-Term Jail Contract with Yakima County; and

WHEREAS the daily charge for an inmate housed in Yakima County Jail will increase to the sum of \$58.80, effective January 1, 2003; and

WHEREAS the City of Renton has provided timely notice to Shoreline of its desire to raise the daily rate for the temporary housing of Shoreline's inmates effective January 1, 2003, now

THEREFORE, the provisions of the Interlocal Agreement between the Cities of Shoreline and Renton, Washington for the temporary custody of inmates before transfer to Yakima County Jail are amended, effective January 1, 2003, as follows:

Section 4. Payment Schedule:

The following amounts are per Identified Offender:

\$25.00 per Identified Offender where that person is in Renton jail for less than 24 hours AND is not detained in the Renton jail overnight.

\$58.80 per Identified Offender where that person is in Renton Jail for less than 24 hours AND is detained in the Renton jail overnight; OR is detained in the Renton jail for a 24 hour period.

\$58.80 per day per Identified Offender where that person is in the Renton jail for more than a 24-hour period.
