PROBLEM/ISSUE STATEMENT: Staff is requesting that Council authorize the City Manager to execute an agreement with Otak Inc., to perform construction administration services for the South (N 145th Street to N 155th Street) and North (N 192nd Street to N 205th Street) sections of the Interurban Trail.

The construction administration services Otak is to provide includes the following major items:

- Daily construction inspection and coordination with contractor;
- Daily documentation of contractor staff, equipment, material installation and working days;
- Coordination with City staff and interaction with the community;
- Tracking of construction material quantities;
- Material review and testing;
- Extensive federal paperwork management for post-construction audit;
- Creation of project as-builts (record drawings);

The City will remain the lead on the project and the primary public information provider.

FINANCIAL IMPACT:

Construction administration services for the south section are estimate at \$115,000 and services for the north section are estimated at \$135,000. There is sufficient funding in the Roads Fund to complete the improvements. The Otak agreement for construction administration services for the south and north sections would expire December 31, 2004. The attached spreadsheet provides an overview of resources and expenditures to complete the south, north and south central sections of the Interurban Trail Project.

RECOMMENDATION

Staff recommends that Council authorize the City Manager to execute a construction administration agreement with Otak Inc., for the Interurban Trail South Section (N 145th Street to N 155th Street) and Interurban Trail North Section (N 192nd Street to N 205th Street) projects for an amount not to exceed \$250,000.
