AGENDA TITLE: Motion to Authorize the City Manager to Execute a Construction

Contract with Paul Brothers, Inc. for the Interurban Trail North Section B (N 200th Street to N 205th Street) and the South Central Section (N.160th Street to N. 175th Street) Improvements and execute change orders up to 10% of the contract amount.

PROBLEM/ISSUE STATEMENT: Staff is requesting that Council authorize the City Manager to execute a construction contract with Paul Brothers, Inc. in the amount of \$1,341,363.70 to perform the construction improvements identified in the Interurban Trail South Central Segment (N.160th Street to N. 175th Street) and North Section B (N 200th Street to N 205th Street) projects. The bid opening was August 31, 2004 and there were 8 bids. Paul Brothers, Inc. bid is the low, responsive, responsible bid. The engineering estimate was \$1,370,000 and Paul Brother's bid was approximately \$29,000 less than the engineering estimate.

The map in Attachment A shows the entire Interurban Trail project and construction phasing plan. The construction of these two trail segments includes approximately 3,200 lineal feet of 12 foot wide trail, a trailhead on N 205th Street (Highway 104) east of Meridian Avenue N, storm drainage improvements, and other amenities such as benches, landscaping, pavement markings and signage.

Paul Brothers, Inc. was the contractor for the South Segment of the trail and staff were pleased with their professionalism, coordination with the community and quality of work. We are confident that the project would be constructed in a timely fashion and of good quality.

References were checked including State Agency fiscal compliance. All references were favorable regarding quality of construction, management of materials and staff and

their fiscal management. Paul Brothers, Inc. is on the Washington State Department of Transportation's (WSDOT) list of prequalified bidders. This means that they have subjected themselves to a rigorous screening to prequalify them to bid on state projects in certain classes of work.

With these items reviewed and the intent to provide fulltime inspection by the City, we feel that the proper controls are in place and a reasonable level of predictability is present to award to this contractor.

FINANCIAL IMPACT: This project is estimated to cost \$1,640,000, which includes construction, construction administration, staff time, utility relocation, contingency and other miscellaneous costs. The costs and revenue allocations are as follows:


