PROBLEM/ISSUE STATEMENT: Staff is requesting that Council authorize the City Manager to execute an agreement with Otak Inc., to perform construction administration services for the South Central (N 160^h Street to N 175th Street) and North B (N 200th Street to N 205th Street) sections of the Interurban Trail.

The construction administration services Otak is to provide includes the following major items:

- Daily construction inspection and coordination with contractor;
- Daily documentation of contractor staff, equipment, material installation and working days;
- Coordination with City staff and interaction with the community;
- Tracking of construction material quantities;
- Material review:
- Extensive federal paperwork management for post-construction audit;
- Creation of project as-builts (record drawings);

The City will remain the lead on the project and the primary public information provider.

FINANCIAL IMPACT:

Construction administration services for the South Central segment are estimated at \$139,000 and services for the North B segment are estimated at \$61,000. The total contract amount would be \$200,000. This contract administration contract is 15% of the construction contract. There is sufficient funding in the Roads Capital Fund and federal grant funds to complete the improvements. The Otak agreement for construction administration services for the South Central and North B segments would expire December 31, 2005. The attached spreadsheet provides an overview of resources and expenditures to complete the south, north and south central sections of the Interurban Trail Project.

RECOMMENDATION

Staff recommends that Council authorize the City Manager to execute a construction administration agreement with Otak Inc., for the Interurban Trail South Central Segment (N 160th Street to N 175th Street) and North B (N 200th Street to N 205th Street) projects for an amount not to exceed \$200,000.
