## Shoreline tightens its belt to maintain critical City services

In last month's *Currents*, City Manager Robert Olander shared that the City may be faced with financial challenges as the national recession has grown worse and impacts are being felt throughout the state. On March 23, staff recommended to the City Council that the 2009 budgeted operating revenues be reduced by 5.4% or \$1.7 million. Reductions were made in the areas of sales tax, gambling tax and development revenues, which have all seen downturns as a result of the recession.

To keep the 2009 budget in balance and provide essential services, staff recommended a three-pronged approach for the City Council to discuss at its April 13 meeting:

1. \$730,000 – Budget reductions including:
  - \$237,500 from shifting some personnel to the capital budget from the operational budget. The City is using staff resources currently available due to the slowdown in development activity to do capital project work normally contracted out.
  - \$131,000 by extending the replacement life of City vehicles and major equipment by four months and not funding 2009 major repair and replacement accounts for City facilities and parks.
  - \$128,000 in reductions by all departments in areas such as supplies, advertising and contracted services.
  - \$75,400 by eliminating services that were backed by development revenues that will not materialize in 2009.
  - \$73,000 by eliminating non-benefited, temporary wages for some “extra-help” employees who assist during busy times.
  - \$60,500 from reducing budgeted travel and training by 20%.
  - \$15,000 of neighborhood/environmental mini-grant funding.

- \$11,000 in police overtime.
- 2. \$376,000 – Budgeted Contingency that was reserved in case revenue estimates needed to be reduced in 2009.
- 3. \$595,000 – Use of 10% of the City's Revenue Stabilization Fund. This fund was created to address revenue shortfalls during short-term economic downturns. This is the first time that the City must use a portion of the fund; the monies will be repaid.

The City will continue to monitor the impacts of the current recession on revenues and its ability to provide the most crucial services to the Shoreline community. ## Federal budget signed by President Obama includes \$950,000 for Aurora

The 2009 budget signed by President Obama last month includes \$950,000 for the final mile of Shoreline's Aurora Corridor Project.

Improving the three miles of Aurora Avenue N through Shoreline has been a community goal since incorporation in 1995. The project improves transit operations, traffic flow and capacity, storm water control, pedestrian safety and comfort, economic development potential and utility infrastructure.

The first mile of the Aurora Corridor

Project between N 145<sup>th</sup> and 165<sup>th</sup> Streets is complete. The second mile, N 165<sup>th</sup> to 185<sup>th</sup> Streets, is set to begin construction later this year. The City of Shoreline has secured nearly a quarter of the funding needed to complete the third and final mile of the project from N 185<sup>th</sup> to 205<sup>th</sup> Streets.

"This funding for the final mile is a big step towards completing the project," Shoreline Mayor Cindy Ryu says.

The City has been partnering with its federal delegation, including Senator Murray, Senator Cantwell, Congressman Inslee and Congressman McDermott's offices, to secure federal funding for the project.

Did you know?

## What you need to know about the Seattle Public Utilities water surcharge

Beginning March 31, Shoreline residents will see an increase in their Seattle Public Utility (SPU) water bills as a result of the City of Seattle increasing their utility tax rate by 4%. This is a temporary increase that applies to all city water customers and will help pay for refunds for fire hydrant costs that were wrongly charged to water customers from 2002 to 2004.

Until 2005, the City of Seattle funded fire hydrant services in its water utility service area through water rates. In 2008, the state Supreme Court ruled that fire hydrants are a basic governmental responsibility that should not be assessed to ratepayers. The court ordered a refund to individual ratepayers by SPU. However, in SPU franchise areas such as Shoreline and King County, the utility was unable to assess the refund, court costs awarded or ongoing hydrant services to the franchising authority under the terms of its franchise.

The surcharge from March 31, 2009, to December 31, 2011, will cover the refunds and other costs ordered by the court since Seattle Public Utilities does not have the cash reserves to pay the refunds. The water utility tax rate will be increased from 15% to 19% for the period of the surcharge.

Anyone who was a Seattle Public Utilities water customer between March 2002 and December 2004 is due a refund. Eligible water customers will get their full rebate later this year.

## Surface Water and Environmental Services

The Surface Water and Environmental Services (SWES) division of Public Works is responsible for a variety of programs that protect the environment.

- Responds to requests to investigate environmental concerns and possible violations of water pollution ordinances.
- Maintains long-term water quality by monitoring sites on streams, lakes and wetlands throughout the City, and participates in salmon recovery planning efforts locally and regionally.
- Inspects and monitors drainage infrastructure to ensure optimal performance and compliance with City ordinances and county, state and federal requirements.
- Implements programs to meet the requirements of the National Pollution Discharge Elimination System (NPDES) permit.
- Educates businesses, residents and schools about what they can do to protect the environment for current and future generations.
- Provides opportunities for the community to practice stewardship at events, workshops and field activities that promote recycling, natural yard care, storm drain stenciling, green remodeling and habitat restoration.

- Monitors activities that contribute to global warming and educates residents and businesses about ways to protect the climate.
- Manages the solid waste collection contract and provides customer service support for other utilities in the City.

# Update: Regional jail planning

A coalition of cities in north and east King County (NEC), led by Shoreline, Bellevue, Kirkland, Redmond and Seattle, announced last November that it was initiating an environmental study on six possible sites around north and east King County for a joint municipal jail.

A new regional jail is needed to replace the beds the cities will lose when King County stops accepting city misdemeanor inmates in about four years.

In order to participate in the study for locating a regional municipal jail, each of the major participants was required to nominate potential sites within their communities. Several sites in Shoreline were identified administratively for further review and staff selected the one located at 2545 NE 200th Street in the Ballinger neighborhood for inclusion in the final environmental review.

The NEC is currently developing an Environmental Impact Statement (EIS) to look at the environmental impacts of building a regional jail at each of the six possible sites. Thanks to Shoreline residents' comments, the EIS will include studies on economic impacts and property values of surrounding communities.

The consultants expect the draft EIS to be completed by mid-August 2009. The public will have an opportunity to comment on the accuracy and content of the DEIS, then the consultants will make appropriate changes before the EIS is finalized in the first quarter of 2010. A final decision on a preferred site will be made by the city councils of each of the NEC Cities.

The Shoreline City Council will deliberate on identifying the preferred site during its meetings, which are open to the public and provide opportunities for community input. The Council will consider several factors in addition to the EIS: the hundreds of community comments; the social and economic impacts to the surrounding neighborhoods; inmate transportation issues; and the location of services needed to help inmates upon release.

Final site selection will be made in conjunction with the other participating cities, but in the end the final site is subject to ratification by the City Council of the city in which the facility would be located.

King County owns one of the six sites selected for the EIS study located in downtown Seattle directly adjacent to the current King County jail. The NEC is actively pursuing partnering with the County to build an annex to the existing jail on that site. Pursuing this partnership option would mean King County would continue to provide jail services to the NEC cities.

However, while the NEC works with King County to determine the feasibility of jointly building and operating a jail annex on that site, it is still necessary for the NEC to continue to study the other five sites.

## Free gun locks available

Shoreline Police are offering free gun locks to Shoreline residents with the help of a grant from Project Home Safe and the U.S. Department of Justice.

The cable locks are designed to work on all types of handguns, shotguns and rifles and come with an instructional booklet and a key. The locks are intended as only one deterrent. Safe storage of guns and talking to your children about gun safety are also important.

Young people may be curious about guns and be tempted to “play” with them. Make sure children in your home are aware of and understand these safety guidelines:

- Don't go looking for guns in your house or a friend's house. Don't let other kids look for guns in your house.
- If you find a gun in your house-or anywhere else-STOP! Leave it alone and don't touch it. Leave the area and tell an adult.
- Even if a gun looks like a toy, don't touch it. Some real guns may look like toy guns, so don't take a chance.
