Dan Pingrey returns to Shoreline as its new Police Chief

The City of Shoreline selected Dan Pingrey of the King County Sheriff's Office as its new police chief. Pingrey replaces Tony Burtt who has been promoted to Chief of the Technical Division of the King County Sheriff's Office.

Pingrey is a familiar face. He first served in Shoreline as a sergeant from 1996 to 1998 and was Shoreline's captain from 2005 to 2007. Pingrey has been with the King County Sheriff's Office for 19 years after

starting his career in Kirkland. His most recent post was in the contracting unit.

"Since Dan served as the second in command here for several years, he is very familiar with the Police Department, community, City staff and elected officials," says Shoreline City Manager Bob Olander. "I am very pleased to welcome Dan back to Shoreline to lead the outstanding team of officers, civilians and volunteers we have in the Shoreline Police Department."

Rather than administering its own police force, the City of Shoreline contracts with King County Sheriff's Office for police services. Officers work for King County

but are dedicated to Shoreline so they get to know the community. The police chief reports to the King County Sheriff and the Shoreline City Manager.

At last year's Spring Clean Sweep, Shoreline residents recycled 440 gallons of oil, 356 computer monitors, 610 fluorescent light bulbs and much, much more. On Saturday, May 3, the City offers another opportunity for Shoreline households to clean out and recycle the clutter at the 2008 Spring Clean Sweep Recycling Event.

This year's event is from 9:00 a.m. to 3:00 p.m. at the Shoreline Park & Ride on N 192nd Street and Aurora Avenue N. To participate for free, single family residents need to bring their new CleanScapes bill, and multi-family residents need to present their driver's license. Due to legal changes required by funding for the event, only residents who subscribe to curbside solid waste collection can participate for free. Shoreline residents who do not have curbside garbage service must pay \$6.75 in cash to participate. Only \$20 bills and under will be accepted.

Only one trip is allowed per household, and please remember to keep children and pets in the car. Some items may require a minimal recycling fee that must be paid in cash, and the City reserves the right to refuse any item. See the event flyer coming in the mail soon or visit www.cityofshoreline.com for guidelines on what to bring and details on fees.

Following a review by the Planning Commission and Parks, Recreation and Cultural Services Board, the City Council held a public hearing on April 14. Council will continue discussion and consider adoption of the proposed strategy in May.

Because the universe of "sustainability" is so vast, the proposed strategy provides overarching direction for future efforts through guiding principles, focus areas, new tools, available resources, and an evaluation of existing programs and staff capacity needed to implement more ambitious projects.



The summer of 2008 is shaping up to be the "Summer of Construction" in the City of Shoreline. With City Hall, numerous park projects and a handful of other capital improvement projects underway, Shoreline expects to have eight or nine projects under construction this summer.

Last month, *Currents* focused on park improvement projects, all of which are listed in the Capital Improvement Plan. This month's focus is on the roads and surface water improvements in the works this year.

Staff completed project designs and bids during the first quarter of 2008 and the second quarter will be dedicated to securing contractors and preparing for construction.

Roads Capital Projects

• Priority Sidewalks – Improvements on Fremont
Avenue North were designed in 2007 and the project is
out to bid. Construction is expected to begin this summer.
Design is underway on two additional routes: 192nd between
the Interurban Trail and Ashworth, and Ashworth between 185th
and 192nd. The 192nd connector should be built later this year.

- Curb Ramp, Gutter and Sidewalk Program Construction is underway on 85 feet of curb and gutter and 4,000 feet of sidewalk in the southwest section of Shoreline.
 - Annual Road Maintenance Program Planning and design are underway to apply asphalt overlay to approximately 5.7 miles of roadway through the annual overlay project in June.
 - Traffic Signal at 150th/15th Avenue NE Callen Construction is beginning work this spring with a completion in late June.
 - The Dayton Retaining Wall was completed at the end of March after significant delays during pile installation and wall construction. Crews will install handrails on top of the wall in May. The roadway in front of the wall will receive new asphalt pavement later this year.


Surface Water Utility Projects

- 18th Avenue NW Drainage Improvement Project Shoreline Construction has almost completed this project to replace failing pipe to reduce localized flooding in the area. N 198th Street between 18th and 20th Avenues NW is closed during construction, which is scheduled to be done by mid-April.
- **Boeing Creek Park Stormwater Project** This project is being done in conjunction with the Boeing Creek Park Project and will increase capacity of the stormwater detention pond, create a trail and add landscaping. Construction is expected to begin in June
- **East Boeing Creek** Design for drainage improvements at 165th and Stone Way and in Darnell Park is nearly complete and the project will be constructed this summer. Improvements along Midvale Avenue are planned for construction in 2009.

• **Pan Terra Pond and Pump** – Final design is almost complete for stormwater improvements at Pan Terra Pond at the corner of 185th and Dayton and replacement of the pump. Construction is scheduled for summer and fall of this year.

• Ronald Bog South – Design continues for the Corliss Avenue pipe replacement and the installation of three fish-friendly box culverts on the creek. The pipe placement is designed and construction is scheduled for this summer. The fish culverts have been submitted to the Washington Department of Fisheries for review and approval. The work must be done within a regulated window of July to September 2008.

New flashing school zone lights coming soon

Thanks to a grant from the Washington State Traffic Safety Commission (WSTSC), Shoreline is installing ten new flashing school zone signs near local schools this year.

The new signs will be similar to the one shown in the photo on N 175th Street near Meridian Park Elementary. This is one of seven that were installed last year, also funded by a grant from WSTSC.

The purpose of the signs is to improve safety and traffic flow in school zones throughout the City.



Two national grants focus on Shoreline youth programs

The City of Shoreline has been selected by School's Out Washington to participate in two new projects involving youth activities after school.

The first is the Supply and Demand Study of after school programs in Washington primarily funded by the Bill and Melinda Gates Foundation. Shoreline is one of three communities selected to represent different urban-rural concentrations. Tacoma is representing the urban population, Shoreline represents suburban and Lower Yakima Valley represents rural.

School's Out Washington will use information gathered through surveys and focus groups (see box) to provide a clearer picture of what kinds of programs are operating



around the state, how many children are being served and what parents and youth really want from an after school program. The report is expected to be completed by the end of the year.

The second program Shoreline is

participating in through School's Out Washington will improve the overall quality of after school programs.

As part of this program, Shoreline Teen Services staff received specific training about ways to improve the quality of youth activities. The Shoreline program is aimed at understanding what program design, structure and activities provide the best experiences for youth. This work is funded through the Ready by 21 Challenge. This Forum for Youth Investment program is aimed at helping state and local leaders ensure that all young people have the support and opportunities they need to be Ready by 21 - ready for college, work and life.

Washington was one of the five states that received a grant to take on the Ready by 21 Challenge. Grants provide training and technical assistance and up to \$100,000 each year for two years in matching grants.

college," says Pingrey. "I also developed some really good relationships with City staff when I was here before. I've been around a lot of cities and Shoreline has quality people with high expectations and I want to be around that type of atmosphere."
