
The change is meant to reduce confusion about meeting start times.

# Fall Clean Sweep Recycling Event is September 25

This year's Fall Clean Sweep Recycling Event is Saturday, Sept. 25, from 9:00 a.m. to 3:00 p.m. at the Shoreline Park & Ride on N 192<sup>nd</sup> Street and Aurora Avenue N. Event flyers will be mailed to all Shoreline residents.

Residents who subscribe to CleanScapes curbside solid waste collection can attend the event for free by showing the mailed event flyer or their CleanScapes bill. Multi-family residents must bring the flyer or their driver's license for free entry to the event. It costs \$6.75 for entry for residents who do not have CleanScapes service. Only \$20 bills and under accepted.

Due to the volume of material typically collected, only one trip is allowed per household. No dump trucks or flat-bed trucks. If you are hauling items on behalf of a neighbor, please call (206) 801-2455 prior to the event. The City reserves the right to refuse any item.

Fluorescent bulbs and tubes will not be accepted. Please call Aurora Hazardous Waste Facility at (206) 296-4692 or recycle bulbs at

Bartell Drugs or Home Depot. TVs, computers, monitors and laptops will not be accepted at the event and can be recycled at Shoreline Goodwill at 14500 15<sup>th</sup> Avenue NE or Deseret Industries at 17935 Aurora Avenue N.

Please use the following guidelines to plan your trip.

### DO BRING:

- All appliances\*
- All batteries
- Cardboard
- Clean scrap lumber and pallets
- Electronics other than TVs, computers, monitors or laptops
- Motor oil, antifreeze and filters
- Porcelain toilets and sinks\*

- Propane tanks\*
- Scrap metal
- Yard waste (no sod, dirt, rocks or grass)

\* Some items may require a minimal recycling fee that must be paid in cash. Check the Clean Sweep Recycling Event flyer for more details.

### DON'T BRING:

- Fluorescent bulbs and tubes, TVs, computers, monitors and laptops.
- Concrete or hazardous materials, such as household chemicals, paint, cleaning products, pesticides, herbicides, solvents and thinners; commercial waste; or items infested by bees, hornets or wasps.

The 2010 Fall Clean Sweep Recycling Event is sponsored in cooperation with the King County Solid Waste Division, the Local Hazardous Waste Management Program in King County and the Washington State Department of Ecology.

## Shoreline City Manager announces February retirement

Shoreline City Manager Robert L. Olander announced to the City Council last month that he will retire in February 2011.

Olander was appointed Shoreline City Manager in March of 2006 after serving as Shoreline's Deputy City Manager from May 2002 to December 2005 and Interim City Manager from January to March 2006.

"Mr. Olander will leave a legacy at the City of Shoreline that we can

all be proud of," says Shoreline Mayor Keith McGlashan. "During his tenure the City has accomplished a great deal, the impacts of which will be felt for decades to come. It has been a great pleasure working with Mr. Olander."

Olander oversaw the completion of major park improvements and open space acquisitions that were part of the City's 2006 Parks Bond; the substantial completion of the first two miles of the Aurora Corridor

Project; and the construction of Shoreline's LEED Gold City Hall.

During Olander's tenure, Shoreline was consistently recognized as a great place to live, both by residents and outside sources. A 2008 citizen survey showed that 93% of residents rated Shoreline as an excellent or good place to live, and *Money* magazine, *Seattle* magazine and *Seattle Met* magazine have ranked Shoreline as a "best place to live."


## Controlling costs: Comparing city staffing

The City of Shoreline's 2010 Budget provides funding for 137 regular full-time equivalent (FTE) positions, excluding City Councilmembers. This reflects a net drop of three (3) FTE positions when compared to 2009.

As the chart at right depicts, a comparison of staffing to population shows Shoreline's staffing levels below the median of comparable cities.

These ratios exclude fire, police, utilities and special program personnel from the comparable cities to provide a more accurate comparison with Shoreline.

September 1, Spartan Rec received its own official address, making it easier for people to find.

Located between the Shoreline Conference Center and Shoreline Stadium, the Spartan Recreation

Center building is owned by the Shoreline School District and operated by the City of Shoreline. It is a prime example of how the joint use agreement between the City and School District helps provide better community use of public facilities.

The City transformed an under-used gym into a facility that is now home to a variety of School District and City parks, recreation and cultural services programs and is used by other local organizations such as the Shoreline-Lake Forest Park Senior Center. The facility is available for drop-in recreation like basketball or volleyball when other programs are not scheduled and can be rented for special events and programs.

# CleanScapes Annual Waste Reduction Rewards competition is now underway

In April, CleanScapes announced the winner of Shoreline's 2009-2010 Neighborhood Waste Reduction Rewards competition. Friday's collection area came out on top by reducing total tons of waste (including garbage, recycling and food scraps and yard debris) by 15%.

Residents living in Friday's collection area, which includes Highland Terrace, Meridian Park, Parkwood, Richmond Highlands (south of N 175<sup>th</sup> Street) and Westminster Triangle will soon be seeing a new \$10,000 community improvement in their neighborhood. Project proposals have been submitted by residents, and the selected project will be announced at the October 18 City Council meeting.

The second annual Neighborhood Waste Reduction Rewards competition is underway now. To win the \$10,000 reward for a community improvement for your neighborhood next year, start reducing waste now and tell your friends, neighbors and local community groups. The neighborhood collection area with the greatest percentage reduction in garbage, recycling and food scraps and yard debris from spring 2010 to spring 2011 wins.

## Aurora Corridor Project N 185<sup>th</sup> to N 192<sup>nd</sup> heads to construction this year, features new Raingarden Plaza

# AURORA CORRIDOR

## N 185<sup>th</sup> to N 192<sup>nd</sup> Streets

The City of Shoreline expects to begin construction later this year for the N 185<sup>th</sup> to N 192<sup>nd</sup> Streets portion of the Aurora Corridor Project. Construction on this part of the project is expected to be completed by the end of 2011, weather permitting.

One new community feature being built in this section is the Raingarden Plaza on the southwest corner of Aurora and N 192<sup>nd</sup> Street. With access to and from the adjacent Park & Ride, the plaza will serve as a demonstration area with educational signs for many of the drainage features and plants installed along Aurora. Beneath the plaza is a major drainage facility to collect the storm water from Aurora Avenue between N 185<sup>th</sup> and N 198<sup>th</sup> Streets. This new system will also control the flow of water that enters Echo Lake.

The plaza will be built on land formerly owned by the State of Washington. Shoreline requested the property from the State for storm drainage purposes. The State declared the land as surplus and transferred ownership to the City at no cost because it agreed that the drainage facility was a necessity that benefitted the public both jurisdictions serve.







# WHY INVESTORS LOVE SHORELINE: Frontage Improvements

An investor walks into a typical city hall and asks, "I'm considering improving property along your highway. What am I required to do?" Typically the answer will include "frontage improvements."

Investors know those two words are loaded with meaning!

By "frontage improvements" the city means improving the property's highway edge with such things as curb, gutter, landscaping, light poles and a sidewalk.

But it means other things to the fire department, the utility providers (sewer, natural gas, water, electricity, telephone, cable) and the state's department of transportation. For example, in response to the growth in highway usage, Washington's DOT is requiring many developers to install medians, turn-pockets, transit facilities and/or traffic signals.

Translation? Time, meetings, consultants, and—of course—money! During my decade working as a real estate developer, I learned to budget at least \$5,000 per linear foot of highway frontage.

Why do investors love Shoreline? Six miles of Aurora, and every foot with completed frontage!\*

Shoreline is definitely not the typical city. Shoreline initiated Aurora's frontage improvements rather than rely on a piece-meal, investor-driven approach. The result? Property with predictable access, property with tremendous visibility and property that is faster and cheaper to improve.

Best of all, when Aurora investors

walk into Shoreline City Hall, they're likely to hear, "We've completed the frontage improvements. Let me show you where to connect your utilities!"

*\* When the Aurora Corridor project is completed in 2013, the total investment in the six miles (three miles on each side) of frontage will be an es-*

*timated \$105 million, or \$3,315 per linear foot. So far Shoreline has secured 85% in federal and state grants and is working on funding for the last half mile. Shoreline's Aurora will feature a rebuilt road base, undergrounded utilities, decorative light poles, synchronized signals and dedicated Business Access/Transit (BAT) Lanes.*

## School's in: please be safe

With school back in session, the City of Shoreline, Shoreline Police and Shoreline School District encourage drivers, pedestrians and bicyclists to pay special attention in school zones and to obey all traffic laws.

### Drivers

- Unless otherwise posted, the speed limit on residential streets is 25 m.p.h. and 20 m.p.h. in school zones.
- Drivers must yield to pedestrians; pedestrians have the right-of-way at intersections even if there is no painted crosswalk.
- It is illegal to pass a car stopped at a marked crosswalk. You must stop.
- When a school bus is stopped with its flashers on, cars behind the bus and in the oncoming lanes must stop and not pass the bus until the flashers are turned off. Traffic separated by an island is not required to stop.

### Pedestrians

- Cross streets only at crosswalks and intersections and never run across the street.
- Don't try to beat oncoming cars – they are moving faster than they appear to be.
- Before crossing, look left, right and then left again. Keep looking both ways until safely across the street.
- Make eye contact with the driver before crossing in front of a car. If you're not sure the driver sees you, wait and let the car pass.
- Walk facing traffic on sidewalks or paths.
- If your child walks to school, walk the route at least once together to offer safety advice.

### Bicyclists


- Always wear a helmet and ride with traffic on the right-hand side of the street. Obey all traffic laws and use proper hand signals.
- Stop at intersections and walk your bike across if the intersection is particularly busy.
- Bicyclists must yield the right-of-way to pedestrians.

## Did you know?

Just because a soap is labeled biodegradable doesn't mean it is harmless to the environment. The term "biodegradable" means that the ingredients in the soap break down faster in the environment than non-biodegradable products. Shoreline residents envision the former Sunset Elementary School site as a place where social and recreation amenities are in balance with nature at nearby Boeing Creek Open Space. With more than four months of public input, this community vision for the two sites has been developed into draft master site plans. The vision will now be refined through a design process and eventual construction.

The Friends of Sunset Park, the Shoreline School District and the City of Shoreline have worked together on the project, and the final public meeting on April 6 and open house on May 18 were positive and productive. The draft master site plans were presented to City Council for review on July 26.

The two properties, Sunset School Park at 17800 10<sup>th</sup> Avenue NW, and Boeing Creek Open Space at 601 NW 175<sup>th</sup> Street, will most likely be developed in phases as funds become available. The sites are designed for complimentary uses which may allow the project to be more competitive for a variety of grants such as open space preservation and urban farming. In the meantime, community groups are encouraged to help by taking on projects that require little or no funding such as building picnic shelters, planting trees and removing invasive plants.

A plan should include meeting spots, medical information, plans for when everyone is away from home and an out-of-state contact person, among other things. Businesses, schools and workplaces should also have plans and September is the perfect time for a staff refresher or writing a first draft.

Most people are familiar with the importance of first aid kits, but preparedness kits are often forgotten or ignored. The second thing everyone can do this month is take a few minutes out of each week to add to your kit. By the time winter is here, you and your loved ones can be more confident and safe in the face of a major earthquake, for example. Kit suggestions include:

- Minimum three-day supply of food and water
- A battery and/or crank-powered NOAA weather radio
- A battery and/or crank-powered flashlight
- Emergency whistle
- First aid kit

Now is also the time to start planning for winter storms and power outages. A great resource for weather alerts and school closings along with transit, road and planning information is Western Washington's "Take Winter by Storm" program at [govlink.org/storm](http://govlink.org/storm).

## Free Prescription Drug Discount Program Cards

The City of Shoreline has launched a program to help provide residents with some relief from the high cost of prescription drugs. The City is making free prescription discount cards available to Shoreline residents through a program sponsored by the National League of Cities (NLC). The discount cards offer residents savings off the retail price of commonly prescribed medications.

The discount card may be used by all residents of Shoreline and has no restrictions based on the resident's age, income level or existing health coverage. The discount card benefits not only those without insurance, but can also be used by under-insured residents to obtain prescriptions that are excluded from health benefit plans. The NLC card can be used when purchasing prescription drugs at participating pharmacies around the City and across the country.

There is no enrollment form required to get a card, no membership fee of any kind and City residents and their family members can use the card any time their prescriptions are not covered by insurance. Cards can be printed from the Internet at [caremark.com/nlc](http://caremark.com/nlc) at no cost. City residents can visit the Caremark website to find a list of participating pharmacies and access program tools or call toll-free (888) 620-1749 for assistance with the program.

The discount card program is administered by CVS Caremark.

## Work on Transportation Master Plan update continues

Shoreline's Transportation Master Plan (TMP) is still a work-in-progress as the City Council continues discussions on sidewalk maintenance and design, bicycle polices and transit and light rail. This month Council will talk about funding and other policy issues it wants to include in the final TMP. These discussions will provide direction for the final TMP update which is scheduled for presentation to Council in early 2011.

A year ago, Shoreline began the process of updating the TMP which helps guide how the City develops its Capital Improvement Program (CIP), coordinates transportation improvements with land uses and

identifies what is needed to respond to growth. The update is necessary due to significant changes and plans for the City's transportation system since the last update in 2005. They include completion of the Interurban Trail, the first mile of Aurora Avenue improvements and the pedestrian bridges, and implementation of bus rapid transit service from Community Transit.

The first step of the update process was an open house to solicit public comments about bicycle and pedestrian transportation and transit in Shoreline. In September 2009, a Bicycle and Pedestrian Advisory Committee (BPAC) comprised of 12

residents was formed to advise staff in the creation of the bicycle and pedestrian elements of the TMP.

To understand how population growth will affect traffic in Shoreline, the City hired DKS Associates to create a traffic model based on future planned land uses. The model will help the City identify where traffic problems are likely to occur so it can plan and budget for future solutions.
