Two suspects were quickly detained in possession loaded ghost-guns and extended magazines. On Thursday, a warrant was served on an SUV yielding a rifle and additional magazines.

Detective Soderstrom shared this summary:

'All three of these are ghost guns were loaded and without any serial numbers or markings. The three weapons have been test fired and function properly. Felony charges of Unlawful Possession of a Firearm are being filed with King County Superior Court Juvenile Division. The juvenile suspect is currently in custody.'

## **Very Good News on TruNarc**



The KCPAO, based on email this week, appears to agree noting that TruNarc, 'would allow [them] to rush file cases without waiting for a test from the crime lab.'



Having prosecutors on-board, as we know, is an important and necessary milestone. This week's development validates the vision and effort of those who've championed TruNarc.
