**RE:** City Wayfinding Design Guidelines

#### INTRODUCTION:

The 2011 Transportation Master Plan identifies the development of a wayfinding signage and mapping system as an important element in the goal to develop a non-motorized transportation system in Shoreline. The City also recognizes the value in a wayfinding system that supports pedestrians and motorist in finding our public facilities and parks.

A project funded by the 2007 six-year King County voter approved trail levy and identified in the 2014-2019 Capital Improvement Plan; the Regional Trail Signage project will create a guiding document and install signage to and from the Interurban trail and to other local and regional trail linkages. The City Wayfinding Design Guidelines document (Attachment A) develops a strategic wayfinding signage plan for pedestrians, bicyclist and motorist. The document outlines policy, provides sign design themes and specifications, identifies destinations, signed routes and proposes sign locations.

Staff and the City's consultant, KPG, have completed the City Wayfinding Design Guidelines and would like to provide the document to Council for your information.

#### **BACKGROUND AND DISCUSSION:**

A Wayfinding Steering Committee (WSC) was created consisting of community volunteers, technical consultant and City staff from the Parks, Recreation and

Cultural Services (PRCS) and Public Works Departments. Through several meetings the WSC identified destinations, bicycle routes, developed sign types and specified sign locations.

City staff and KPG used the information gathered at these meetings along with the 2011 Shoreline Bicycle System Plan and the 2011, Shoreline Pedestrian System Plan to create the layout of the signed routes (Attachment B). Wayfinding signs will be installed in phases and only after pedestrian and bicycle facilities are in place. Sign types follow AASHTO and MUTCD guidelines (Attachment C).

While vehicular sign styles and specification are also included in the guidelines, sign locations have not been determined and are not mapped out.

Staff and their technical advisory group presented the results of the WSC meetings to the PRCS Board on October 24, 2013. A public open house was held on December 5, 2013 where the plan and information presented was received positively. Staff reported back to the PRCS Board to present the final City Wayfinding Design Guidelines document on March 27, 2014.

The document is intended as a resource to be used by staff and updated in the future as opportunities arise to further develop the City's wayfinding system through other capital and development projects. Implementation will be completed through phases, with Phase I implementation focusing on signage on or near the Interurban Trail as well as streets with existing bicycle facilities.

The City of Shoreline received approximately \$655,000 from 2007 to 2013 from the 2007 King County Trail Levy. Levy funds can be used for acquisition and development of regional trails and connectors to those trails. The Interurban Trail which runs north and south through Shoreline for 3.25 miles is one of those regional trails. The Regional Trail Signage project will use \$168,491 of the Levy for development of the City Wayfinding Design Guidelines document and Phase I sign implementation. Of that amount, approximately \$117,000 is available for Phase I sign implementation. The other two projects which have used the 2007 King County Trail Levy funds are the Park at Town Center Master Plan and tree planting completed in 2012 and the Echo Lake Improvement Project scheduled to be completed this summer.

Preparation of plans and specifications for Phase I implementation is currently underway. Bid documents are expected to be complete by June, 2014 and construction complete in December, 2014.

# 1.0 INTRODUCTION

The City of Shoreline recognizes the need to create a comprehensive city wayfinding signing plan that benefits pedestrians and bicyclists by improving connectivity and fulfilling the community's vision of providing safe transportation alternatives. The wayfinding signing plan may also encourage motorists to use alternatives by providing direction to destinations and additional levels of comfort for those navigating through the City.

The report supports the project goals, outlines policy context, provides sign design themes to enhance the character and identity of the City, identifies destinations, signed routes, and proposes sign locations for a pedestrian and bicyclist wayfinding signing plan.

#### 2.0 PROJECT OVERVIEW

#### 2.1 PROJECT GOALS

- Create a comprehensive wayfinding signing plan for City identified destinations for users on the Interurban Trail and bicyclists on designated bicycle routes within the City
- Enhance the experience of the Interurban Trail and pedestrian environment
- Increase mobility throughout the City, on and off the trails, especially alternative travel modes like walking and biking
- Make information more visually accessible to residents and visitors
- Improve linkages to different destinations, particularly where there seems to be a physical and/or topographical barrier
- Establish wayfinding as part of a unified system to connect to adjacent municipalities and regional trails
- Encourage place-making along the Interurban Trail and around the City of Shoreline

#### 2.2 DESIGN APPROVAL PROCESS

The city wayfinding signing guidelines went through a design/stakeholder approval process where a Wayfinding Steering Committee (WSC), consisting of community volunteers, technical advisory group, City staff members from Parks, Recreation and Cultural Services (PRCS), Planning and Traffic departments, was formed to refine the city wayfinding signing guidelines. Through several meetings the WSC identified significant destinations, developed eight wayfinding sign types, conceptualized the vehicular wayfinding sign standard, specified sign locations and identified bicycle routes that promote a secure wayfinding network for alternative transportation. The city wayfinding signing guidelines were presented to the PRCS Board, to the community at a public open house, to City Council, and again to the PRCS Board for approval.

#### 2.3 CITY WAYFINDING SYSTEM

The Shoreline Bicycle System Plan (2011) and the Shoreline Pedestrian System Plan (2011) provide a framework to layout the signed routes for the city wayfinding signing plan; see Appendix A: City Reference Maps. The city wayfinding sign family also references Shoreline's pilot vehicular wayfinding project and N 175th Street and Meridian Avenue N.




Figure 2: City Wayfinding Signing Plan

A comprehensive 37-mile network of routes with bicycle facilities and supporting signs map out the city wayfinding signing plan, shown on Figure 2. The interurban trail and signed routes will provide direction across north/south and east/west corridors. Wayfinding signs will be installed in phases and only after necessary pedestrian and bicyclist facilities are in place. The goal of the city wayfinding signing plan is to easily and comfortably guide pedestrians and bicyclists throughout the City of Shoreline.

Designs and final locations for potential kiosks and interpretive signs along the Interurban Trail, shown on Figure 2, will be refined in the future. As additional bicycle routes and signs are designed, implemented and installed, the guidelines will be updated to reflect best practices.

#### 3.0 PEDESTRIAN AND BICYCLIST SIGN STANDARDS

#### 3.1 SIGN CONTENT

Wayfinding sign content includes a broad range of destinations, mileages, and symbols and logos. Redundancy in sign content (destination and distance information) should be avoided, and wherever possible signs have been consolidated to one location providing more efficient directions to different points of interests.

#### 3.1-1 Destinations

The WSC established a list of key destinations that would be shown on destination blade signs. Each destination is organized into one of five destination categories: parks, civic, academic, local, and city destinations. These destinations, determined to be important to cyclists and pedestrians, lie within close proximity to signed wayfinding routes and establish a key list of Shoreline destinations.

The WSC recognized that providing names of individual commercial businesses, private institutions, restaurants and other non-public destinations would be problematic. The large number of these types of destinations throughout the City as well as limited space on the signs makes it challenging to be entirely inclusive. Additional wayfinding signage may be installed as new destinations, such as the Sound Transit light rail stations, are developed in the future.




Figure 3: City Wayfinding Destinations Map

#### 3.1-2 Abbreviations

The WSC established a list abbreviations and shortened texts for certain destinations in order to compensate for multiple words and long characters. In the case where a destination has the City's name, it should be withheld from destination blade text (i.e. "Shoreline Police Station" becomes "Police Station"). There are three exceptions in which the City's name should be used: Shoreline Pool, Shoreline Stadium, and Shoreline Community College.

A period will not be placed after an abbreviated destination to conserve character space on signs (i.e. Dept, not Dept.). The WSC determined that signs directing users to Richmond Beach destinations will be signed as "Richmond Beach" until you arrive at the intersection of NW 195th Street and 15th Avenue NW. At this point individual destinations names for the Richmond Beach neighborhood will be used.

The abbreviations and shortened texts should be consistent throughout the city wayfinding signing plan and destination list. See Table 2 below for a complete list of abbreviations and shortened texts.




Figure 4: Symbols and Logos

# 3.1-3 Symbols and Logos

Each sign type in the city wayfinding signing plan have a symbol, a combination of symbols, or the City of Shoreline's logo. The following list of ten destinations will receive a single arrow symbol and bicycle symbol on both the double-sided and single-sided destination blades (Sign Types A and B1):

9. Shoreline Pool

- 1. Town Center 5. Shorecrest High School
- 2. Shoreview Park 6. Shorewood High School 10. Shoreline Stadium
- 3. Hamlin Park 7. Interurban Trail
- 4. City Hall 8. Spartan Recreation Center

On a destination blade that receives both the arrow and bicycle symbols it will also depict the mileage to that particular destination. The Interurban Trail destination blades will only depict mileage up to 0.5 miles from trail. The WSC specified only these ten destinations will highlight mileage information as they are key destinations for the City. All logos are oriented the same direction as the arrow.

Destinations and Signs that Receive Symbols

- 1. Police Symbol: Shoreline Police Department
- 2. Post Office Symbol: Post Office
- 3. Library Symbol: Shoreline Library, Richmond Beach Library
- 4. Bicycle Symbol: The ten destinations that receive mileage information (listed above), and Sign Types C, D1, and E
- 5. Pedestrian Symbol: Not specific to any destination, for Sign Types D1 and E only
- 6. Single Arrow Symbol: Occurs on all destination sign blades, and Sign Type D2
- 7. Double Arrow Symbol: Not specific to any destination, for Sign Type D3 only
- 8. Transit Symbol: Aurora Village Transit Center, Shoreline Park-n-Ride
- 9. Shoreline Logo: Interurban Trail Sign Blade (Type A) and Shoreline Logo Sign (Type B2) only

#### Color

- 1. Shoreline Logo
  - A. Trees: Green; R-0, G-128, B-77
  - B. Text with Line: Blue; R-10, G-71, B-157
  - C. Waves: Gradient of Blues with darker blue starting from left edge
    - a. Darker Blue; R-151, G- 178, B-218
    - b. Lighter Blue; R-201, G-215, B-233
- 2. Symbols
  - A. All symbols: White; R-255, G-255, B-255

#### Size

1. Symbol and logo sizes vary per each sign type, see Figures 6-14 for size details.

#### 3.2 SIGN TYPES AND STANDARDS

The city wayfinding signing plan will provide pedestrians and bicyclists with direction, destination and distance information as well as establish bicycle routes. In assisting cyclists and pedestrians, the city wayfinding signing plan will provide guidance through the use of eight sign types:

- 1. Type A: Interurban Trail Directional Signs: Occurs at major decision points, and intersections, along the Interurban Trail to provide directional guidance and primary destination information.
- 2. Type B1: City Directional Signs: Occurs at decision points along primary on-street cyclist routes (as specified by the WSC) to provide directional guidance and primary destination information at intersections.
- 3. Type B2: Shoreline Logo Sign: Occurs at the City border along primary cyclist routes to inform cyclist upon entering Shoreline. This sign type will be mounted on top of sign Type B1.
- 4. Type C: Confirmation Signs: Occurs along primary cyclist routes to confirm upcoming municipality and route choice for exiting Shoreline, and if paired with sign Type D2, or D3, can provide additional guidance at turns.
- 5. Type D1: Trail Route Signs: Directs riders to Interurban Trail from the street.
- 6. Type D2: Single Arrow Auxiliary Signs: Supplemental sign providing direction at turn points and intersections. This sign type will be mounted below sign Type C, D1, or E.
- 7. Type D3: Double Arrow Auxiliary Signs: Supplemental sign providing direction at turn points and intersections. This sign type will be mounted below sign Type C, D1, or E.
- 8. Type E: Connector Sign: Occurs along primary cyclist routes to direct cyclists to the Interurban / Burke Gilman Connector route, and occurs along the Interurban / Burke Gilman Connector route to confirm cyclist is on the connector route.


The city wayfinding sign family adopts a color scheme that establishes uniformity among the sign types and reinforces Shoreline's logo and identity. Sections 3.2-1 through 3.2-8 specify individual sign colors using the RGB color system. The RBG color system is a composition of three primary colors: red (R), green (G), and blue (B). Each color in the RGB spectrum is created first by having a dark canvas (or design area) and then adding each of the red, green and blue elements. For this reason it is also known as the Additive Color System.

The eight sign types have been modeled from the bicycle sign standards currently found in the Manual on Uniform Traffic Control Devices (MUTCD) guidelines for directional bicycle signage in part, with a few modifications for identity enhancement and branding. More informing documents include the following:




Figure 5: City Wayfinding Sign Family

#### 3.2-1 Interurban Trail Directional Sign

Interurban Trail Directional signs include a double-sided Interurban Trail blade (with City logo), double-sided destination blades with directional arrows, symbols, destination names and mileage information.

#### Sign Blades





Figure 6: Double-Sided Interurban Trail Blade

- 1. Interurban Trail Blade (see Figure 6)
  - A. Color: White; R-255, G-255, B-255
  - B. Located above all Destination Blades.
  - C. Blades are doubled-sided
- 2. Destination Blades (see Figure 7 and 8)
  - A. Color: Blue; R-10, G-71, B-157
  - B. Blades are double-sided

#### Sign Content

- 1. Destinations
  - A. There is a maximum of 6 destination blades (one destination per blade), with or without mileage, per sign pole location.
- 2. Text: Interurban Trail Blade
  - A. Will always read "Interurban Trail"
  - B. Color: Black; R-0, G-0, B-0
  - C. Font: Clearview Highway Type C, 2-inch cap height
  - D. First letter of each word capitalized, remaining letters lower case
  - E. Alignment: centered on low arc
- 3. Text: Destination Blades
  - A. Maximum characters per destination blade (includes characters for mileage, where applicable):
  - 17-23, see Figures 7 and 8 for maximum character details
  - B. First letter of each word capitalized, remaining letters lower case
  - C. Font: Clearview Highway Type C, 2-inch cap height
  - D. Color: White; R-255, G-255, B-255
  - E. Alignment: justified left
  - F. Double-sided blade text varies per sign location. Text variations for a single blade may include (on either side): same destination, two different destinations, single destination and blank side.

    Refer to wayfinding matrix in Appendix B for destination text content.

#### 4. Mileage

A. Mileages will be illustrated in whole numbers and decimals rounded to the nearest tenth (i.e. 0.8, 1.5, 3.0). In the instance where character space is severely limited on a sign blade, whole numbers can be reduced to whole numbers only (i.e., 2 rather than 2.0). Distance measurements are made from the intersection at which the sign will be located to the nearest point/point of

entrance to a given destination.

- B. Font: Clearview Highway Type C, 2-inch cap height
- C. Color: White; R-255, G-255, B-255
- D. Mileages will be located immediately following destination text with one character space separation.

#### 5. Logos and Symbols

- A. Shoreline city logo is located on the Interurban Trail Blade only.
- B. Refer to section 3.1-3 for complete list of symbols and specifications on destinations that receive symbols. Refer to Appendix B for sign locations, destination information, and arrow direction. Size symbols as noted in Figures 5 and 6.
- C. Bicycle symbol is always oriented in the direction the arrow is pointing.
- D. Single arrow symbols to be placed on each destination blade, sized as noted in Figures 5 and 6.
- E: Symbols color: White; R-255, G-255, B-255

#### Organization of Sign Content

- 1. Destination is straight ahead: arrow is left justified with bicycle logo to the right. Text is left justified, immediately following symbols, followed by mileage.
- 2. Destination is to the right: arrow is right justified with bicycle logo to the left. Text is left justified followed by mileage.
- 3. Destination is to the left: arrow is left justified with bicycle logo to the right. Text is left justified, immediately following symbols, followed by mileage.

# Organization of Signs within a Sign Assembly

- 1. The sign with the nearest destination goes at the top of the assembly with the most distant destination at the bottom. If destinations are equal in distance, the sign with a straight ahead arrow should be placed on top. This arrangement allows for the nearest destination to "fall off" the top of the sign and subsequent destinations to move-up as the cyclist approaches.
- The number of signs on a given post pointing in the same direction is not to exceed four. Limiting destinations to two in one direction is necessary to provide space for destinations in other directions as this sign type will occur at intersecting routes.
- 3. The number of destinations provided on a given post is not to exceed six. This allows for the proper vertical clearance of 7'-6" to be maintained.

# Sign Placement

- 1. Interurban Trail Directional signs are placed at decision points along the trail where signed routes and arterial roadways intersect the Interurban Trail.
- 2. Signs are be located at trail splits.

- 3. Placing signs at these locations reinforces the use of designated routes from the Interurban Trail. The regional wayfinding system has been designed to connect parks and open spaces, civic, academic and local destinations, and important locations beyond the City of Shoreline that in many cases fall directly on a designated route.
- 4. Sign Location
  - A. 24" minimum setback from back of curb or edge of sidewalk pavement
  - B. 5' minimum setback from driveways

# Sign Type A: Interurban Trail Blade Interurban Trail Directional Signs, Custom Size

# 3.2-2 Shoreline Logo Sign

Shoreline Logo signs are single-sided, include only the City logo and occur only at the City border along primary cyclist routes to inform cyclist upon entering Shoreline.

# Sign

1. Color: White; R-255, G-255, B-255

#### Sign Content

- 1. Logo
  - A. Each logo sign will have one Shoreline logo, and shall be centered on the sign and sized according to Figure 10 below.
  - B. See section 3.1-3 for logo.

# Organization of Signs within a Sign Assembly

1. The sign is paired with Sign Type B1, City Directional Sign, and is located above all directional blades and accompanying supplemental signs.




Figure 9: Single-Sided Shoreline Logo Sign

#### 3.2-3 City Directional Sign

City directional signs are single-sided destination blades that include directional arrows, symbols, destination names, and mileage information.

#### Sign Blades

1. Color: Blue; R-10, G-71, B-157

#### Sign Content

- 1. Destinations
  - A. There is a maximum of 6 destination blades (one destination per blade), with or without mileage, per sign pole location.
- 2. Text: Destination Blades
  - A. Maximum characters per destination blade (includes characters for mileage, where applicable):
  - 18 23, see Figure 9 for maximum character details
  - B. First letter of each word capitalized, remaining letters lower case
  - C. Font: Clearview Highway Type C, 2-inch cap height
  - D. Color: White; R-255, G-255, B-255
  - E. Alignment: justified left
- 3. Mileage: Destination Blades
  - A. Mileages will be illustrated in whole numbers and decimals rounded to the nearest tenth (i.e. 0.8, 1.5, 3.0). In the instance where character space is severely limited on a sign blade, whole numbers can be reduced to whole numbers only (i.e., 2 rather than 2.0). Distance measurements are made from the intersection at which the sign will be located to the nearest point/point of entrance to a given destination.
  - B. Font: Clearview Highway Type C, 2-inch cap height
  - C. Color: White; R-255, G-255, B-255
  - D. Mileages will be located immediately following destination text with a one character space separation.
- 4. Symbols: Destination Blades
  - A. Refer to section 3.1-3 for complete list of symbols and specifications on destinations that receive symbols. Refer to Appendix B for sign locations, destination information, and arrow direction. Size symbols as noted in Figure 9.
  - B. Bicycle symbol is always oriented in the direction the arrow is pointing.
  - C. Single arrow symbols to be placed on each destination blade, sized as noted in Figure 9.
  - D. Color: White; R-255, G-255, B-255

# Organization of Sign Content

1. Destination is straight ahead: arrow is left justified with bicycle logo to the right. Text is left justified,


- immediately following symbols, followed by mileage.
- 2. Destination is to the right: arrow is right justified with bicycle logo to the left. Text is left justified followed by mileage.
- 3. Destination is to the left: arrow is left justified with bicycle logo to the right. Text is left justified, immediately following symbols, followed by mileage.

#### Organization of Signs within a Sign Assembly

- 1. The sign with the nearest destination goes at the top of the assembly with the most distant destination at the bottom. If destinations are equal in distance, the sign with a straight ahead arrow should be placed on top. This arrangement allows for the nearest destination to "fall off" the top of the sign and subsequent destinations to move-up as the cyclist approaches.
- 2. The number of signs on a given post pointing in the same direction is not to exceed four. Limiting destinations to two in one direction is necessary to provide space for destinations in other directions as this sign type will occur at intersecting routes.
- 3. The number of destinations provided on a given post is not to exceed six. This allows for the proper vertical clearance to be maintained.

#### Sign Placement

- City directional signs are placed at decision points where signed routes intersect and where routes lead directly to the intended destination. Placing signs at these locations reinforces the use of the designated routes. The city wayfinding system has been designed to connect parks and open spaces, civic, academic and local destinations, and important locations beyond the City of Shoreline that in many cases fall directly on signed routes.
- 2. When city directional signs are placed on regional routes or they point users directly to signed routes, Trail Route Signs (Sign Type D1) may be placed on the same sign post below the blades. Placing multiple sign types on one post will reduce the number of posts used as well as provide all necessary information for bicyclists in one location.
- 3. Signs are placed at the approach to an intersection route:
  - A. 100' before an intersecting route
  - B. 200' on a two lane merge within the block approaching the intersection route
- 4. Sign Location
  - A. 24" minimum setback from back of curb or edge of sidewalk pavement
  - B. 5' minimum setback from driveways
  - C. 100' minimum setback from intersections



#### 3.2-4 Confirmation Sign

Confirmation signs confirm route choice and provide guidance upon entering an adjacent municipality. They can also be used with an auxiliary arrow sign (Sign Type D2 or D3) to provide direction at a turn in a route that is not a regional route. Confirmation signs include destination information generally with the text "To" before the location indicated on the sign. In cases where a confirmation sign is found on a signed route and the route must be confirmed after a turn has been made, a trail route sign (Sign Type D1) may be placed below the confirmation sign.

- 1. Color: Blue; R-10, G-71, B-157
- 2. Border color: White; R-255, G-255, B-255

- 2. Symbols




Figure 11: Confirmation Sign

  - A. Bicycle symbol, sized as noted in Figure 11. The bicycle symbol is always oriented to point to the left edge of the sign.

#### 3.2-5 Trail Route Sign

Trail Route signs direct pedestrians and cyclists to the Interurban Trail from the street. Trail route signs are used in conjunction with auxiliary signs Type D2 or D3 (reference MUTCD M7 sign series) to inform users of proper direction to the trail.

- 1. Border and oval color: Blue; R-10, G-71, B-157
- 2. Internal color: White; R-255, G-255, B-255

- A. Top line reads "Interurban", middle line reads "Trail", and bottom line is unused

#### 3.2-6 Single Arrow Auxiliary Sign




Figure 13: Arrow Auxiliary Signs

#### 3.2-8 Connector Sign

Connector signs occur along signed routes to direct cyclists and pedestrians to the Interurban / Burke Gilman Connector Routes. They also occur on signed routes between the Interurban Trail and Burke Gilman Trail to confirm the user in on the connector route. Connector signs are used in conjunction with auxiliary signs Type D2 or D3 to inform users of proper direction to the trail. See Figure 22: Interurban / Burke Gilman Connector Routes in Appendix B for route location.




Figure 14: Connector Sign

#### 3.3 INSTALLATION SPECIFICATIONS

#### Post Height




Figure	15. Sign	Heights	for	Roadways	and	Trails

For post and sign height, different standards apply for trails and roadways. Figure 15 illustrates optimal sign height assemblies on freestanding posts along roadways and trails whereas Table 3 establishes guidelines for post height in different situations. In cases where right-of-way space is limited, vertical clearances become crucial for pedestrian safety (i.e. signs placed on the sidewalk). All city wayfinding signs are to adhere to these heights, in addition to sign height standards for signs in the right-of-way (see section 3.4), for adequate lateral clearance and system uniformity. If sign assemblies include signs of different sizes, sign post guidelines should apply to the bottom of the widest sign.


Three types of posts will be used for the wayfinding signing system. All post types will use the following fastening equipment: type 316 stainless steel fasteners; zinc plated fasteners with coating complying with ASTM B633, class Fe/Zn 5.

- 1. 3" diameter aluminum 6061-T6 post
  - A. Use for sign Type A, Interurban Trail Directional signs, only
  - B. Aluminum base used in combination with this post
- 2. 2.5" square Telespar Unistrut post
  - A. Use for sign Types B1, City Directional signs, only
  - B. Refer to the Shoreline Engineering Development Manual (EDM) for standard details
- 3. 2" square Telespar Unistrut post
  - A. Use for sign Types C, D1, and E
  - B. Refer to the Shoreline Engineering Development Manual (EDM) for standard details

## Signs/Blades

Signs and sign blades follow the thickness specifications illustrated in Figure 16. The sign widths have been determined based on wind factors, sign size, and mounting style. Shoreline uses the following specifications/product types (per WSDOT specifications) to produce wayfinding signs:

- Material: Aluminum sheet metal plate, comforming to ASTM B209 alloy 6061-T6
- Reflective sheeting: Type II glass bead retroreflective sheeting

#### 3.4 SIGN PLACEMENT PRINCIPLES

The city wayfinding signing plan consists of points and paths. Points are the main feature of the system. They are locations where signs are placed for bicyclists to make a decision at the intersection of two signed bicycle routes. At these locations Type B1 signs will provide destination, directional arrows and distance information to allow bicyclists and pedestrians to make a decision to go toward major destinations throughout the city.

Paths are named trails or routes such as the Interurban Trail, Meridian Avenue North, and North 155th Street that require signage to guide cyclists along these on- and off-road routes. Type A and B1 signs will be provided along the paths for continued guidance towards a destination.

#### Sign Placement within the Right-of-Way




Figure 17: MUTCD Guidelines for Sign Placement on Shared-Use Paths

Following the Shoreline EDM, Shoreline Transportation Master Plan, MUTCD, and AASHTO guidelines, Table 4 and Figure 17 illustrate sign placement principles for signs located in the right-of-way and along shared-use paths. For additional standard clearances not listed in Table 4 see Shoreline EDM. Proper lateral placement of wayfinding signs allows for adequate visibility of the sign from the roadway, and it establishes proper spacing between sign edge and vehicles so that traffic does not damage the sign.

Along roadways, where urban elements (trees, furniture, etc.) influence sign location, placement should be based on the judgment of the designer/engineer. It is important to consider the amount of distant needed for a cyclist to read the sign and make a decision on direction as they approach an intersection.

#### Field Measurements

Identifying the exact placement of a sign is crucial to the effectiveness of the sign as well as preventing damages by vehicular traffic. When placing a sign in the field, follow sign placement principles such as measuring from centerlines, curblines, or back of sidewalk, respectively.

When locating new posts a spray mark (white) should be made on the surface (grass, concrete, etc.) illustrating the direction the sign will face and sign type.

## 4.0 VEHICULAR SIGN STANDARDS

#### 4.1 SIGN CONTENT

Vehicular wayfinding signs are currently in the early conceptual phase and will be implemented in the future. The signs have been modeled from an existing pilot vehicular wayfinding project at N 175th Street and Meridian Avenue N to fit with the pedestrian and bicyclist wayfinding signs.

#### 4.1-1 Destinations

Destinations for vehicular wayfinding signs will be established in the future.

## 4.1-2 Symbols and Logos

Symbols and logos for vehicular wayfinding signs will be established in the future.

#### 4.2 SIGN STANDARDS




Figure 18: City Reference Map - Bicycle System Plan

Vehicular wayfinding signs are single-sided and are intended to direct and inform motorists of key destinations throughout the City. See Figure 18 for sign size specifications.

- A. First letter of each word capitalized, remaining letters lower case

- 3. Symbols and Logos

    - 1. For destinations left and straight ahead, arrow symbol justified left.
    - 2. For destinations right, arrow symbol justified right.




Figure 20: City Reference Map - Pedestrian System Plan




Figure 21: Comprehensive City Wayfinding Signing Plan




Figure 22: Interurban/ Burke Gilman Connector Routes




Figure 2: City Wayfinding Signing Plan




Figure 5: City Wayfinding Sign Family
