I am glad you enjoy Cromwell Park.

Yes, Tent Caterpillars are very unsightly but the City of Shoreline Parks Department does not remove or treat them with insecticide.

It is my understanding that they provide a good food source for birds, insects and other creatures. They do little actual harm to trees, to kill them we would have to use an insecticide (which we do not do) and they go in cycles. Meaning, roughly every 6 years they get really bad and lessen the next year, etc, etc, until there are very few and then the cycle starts over.
