**RE: City of Shoreline proposed assumption of Ronald Wastewater Dist. within Snohomish County (BRB No. 04-2014)**

Concerning the above proposed assumption, the Boundary Review Board's jurisdiction was invoked by the Snohomish County Council on July 7, 2014, Olympic View Sewer and Water District on July 8, 2014 and the Town of Woodway on July 9, 2014. Accordingly, the Board shall make a finding (RCW 36.93.150) within 120 days after jurisdiction was first invoked (July 7, 2014) or within 40 days of the conclusion of its hearing. Following adoption of the Board's decision, there is a 30-day period (RCW 36.93.160) within which any affected governmental unit, property owner, or resident of the proposed assumption area may file an appeal in Superior Court.

The following schedule has been set for the hearing and decision-making process. The hearing, deliberation and decision-making will be held at 4:00 p.m. in Public Meeting Rooms 1 & 2 on the 1<sup>st</sup> Floor of the Robert J. Drewel Building located at 3000 Rockefeller Avenue, Everett, WA

Thursday, August 28, 2014

Public Hearing on the above-named proposal. Deliberation and decision-making will follow.

Thursday, September 11, 2014

Adoption of Written Decision (held in the Public Meeting Room 1 on the 1<sup>st</sup> floor of the Robert J. Drewel Building)
