- Week of 8/25: <http://shorelinewa.gov/home/showdocument?id=18024> – *Selection of the 185th Street Station Preferred Alternative to be Studied in the Final Environmental Impact Statement (FEIS):* Council selected the preferred alternative to be studied in the FEIS. This map will be posted on the City's website. Following the FEIS, the next steps will include review of the

proposed 185th Subarea Plan by the Planning Commission later this fall to develop a final recommendation for the Council to consider in early 2015.

Input from Council will be used to start putting together potential zoning scenarios to be used in the Draft Environmental Impact Statement process. Zoning scenarios will be reviewed by Council on September 15, and these zoning scenarios will be used in the second Design Dialogue Workshop scheduled for October 9.
- Week of 8/11: <http://shorelinewa.gov/home/showdocument?id=17932> – *Discussion of the 185th Street Station Subarea Plan Preferred Alternative*: Council discussed the preferred alternative that should be used for the Final Environmental Impact Statement analysis (FEIS). **Council waived Council rules to allow public comment after the staff presentation on this item.** Council will make the selection of the Preferred Alternative on August 25.
- Week of 8/4: <http://shorelinewa.gov/home/showdocument?id=17861> – *Discussion of the 185th Station Subarea Plan Preferred Alternative*: The Council will discuss the preferred alternative that should be used for the Final Environmental Impact Statement analysis (FEIS). The Planning Commission (PC) made additional proposed changes to the station area zoning map at the Public Hearing on July 10. Given that the PC made changes that were not previously published to the public, **Councilmembers have expressed interest in waiving Council rules on August 11 to allow public comment after the staff presentation on this item.** Council will make the selection of the Preferred Alternative on August 25.

Here is a link <http://shorelinewa.gov/home/showdocument?id=17377>. The comment period ends on July 10. This is the same evening that the Planning Commission will hold a public hearing on the DEIS. We had approximately 100 people attend the DEIS Workshop on June 3. On June 12 we had nearly 100 people attend the 145th Light Rail Design Dialogue Workshop. Although some attendees had concerns with how the station may change their existing neighborhoods, many are excited about the possibilities that will come with the new station and the transformation that this will bring.
- Week of 6/2: <http://shorelinewa.gov/home/showdocument?id=17236> **Light Rail/145th Update** Secretary of Transportation Peterson and the Assistant Secretary of Transportation (Amy Scarton) have confirmed attendance for the Council Dinner Meeting on August 25. Staff will take them on a tour of the corridor that afternoon (to share vision, etc.) and then have them attend the dinner meeting with Council. Grants update: The City actively participates in evaluation and application of regional grant dollars. This week we received notification that the Shoreline will receive \$246,000 to supplement the \$250,000 authorized by Council for the 145th Route Development Plan. Also through the King County recommendation process Shoreline is on the recommended funding list for \$4.15 million for 145th design/environmental and is first on the contingency list for \$3.5 million for design/environment of 175th between Stone and I-5. These recommendations go to the King County Project Evaluation Committee on June 9 and then to the Transportation Policy Board of the Puget Sound Regional Council who ultimately makes a recommendation to the PSRC Executive Board. We will continue monitor this process and

advocate for funding for these Shoreline projects! Congratulations to the key staff who have been working on this which includes: Kirk McKinley, Bethany Wolbrecht-Dunn, and Alicia McIntire. This group receives additional support for these efforts from Jay Clark, John Vicente, Iain Draper, Noel Hupprich, David LaBelle and Tricia Juhnke. Great teamwork for Shoreline!

During the scoping period, the City submitted its comment letter and identified several specific projects the City wanted to see included in the Long Range Plan update. During its update to the Board, ST staff outlined potential plan modifications (including maps showing modified bus service and modified rail service) that could be incorporated as part of the update. ST staff explained that these modifications could be added to the existing plan and that projects/corridors in the existing plan would be incorporated into the update. Specific items that we included in our comment letter that are identified as potential plan modifications include:
 - Improvements to 145th Street (identified as a representative corridor improvement)
 - Improved east-west service in Shoreline connecting SR 99 BRT, I-5 LRT and SR 522 HCT (identified as a representative bus refinement)
 - ST regional express bus service on 145th from I-5 serving SR 522 (Project 29 on the map showing potential plan modifications for buses)
 - HCT line from downtown Seattle to Edmonds via Ballard, Shoreline Community College (Project 20 on the map showing potential plan modifications for rail). The mode for this project is not specified however we recommended light rail. Our comment did not include extension to Edmonds.
 - Light rail from North Kirkland/or UW Bothell to Northgate via SR 522 (Project 10 on the map showing potential plan modifications for rail)

Mayor Winstead and Deputy Mayor Eggen were in the audience, in addition to the Chair and light rail committee of the Planning Commission. The presentation included SketchUp modeling of potential build-out of 3 zoning scenarios presented to Council on February 8. More detailed modeling and cross-sections of potential improvements to NE 185th Street and its bridge were also shown. The word of the night was POSSIBILITIES and it was emphasized that images represented a few possibilities of how the neighborhood could transform over decades, based on market forces and homeowner decision-making.

- **Week of 1/27: <http://shorelinewa.gov/home/showdocument?id=15656> – Light Rail Update: Sound Transit is starting field work for the Lynnwood Link Extension Final Environmental Impact Statement (FEIS), including noise monitoring, vibration testing and monitoring, civil and wetlands survey work, and geotechnical drilling. Some of the work will be performed in WSDOT or City right-of-way and some of the work will need to be performed on private property. We should expect to see orange vests along the project corridor. See [Sound Transit's fact sheet](#) that outlines the nature of the work.

Sound Transit is contacting private property owners to request rights of entry to perform some of this work. There is likely to be some confusion among property owners about what the rights of entry mean and how it relates to property acquisition and project status. The area for testing is different than the area where property acquisition is anticipated. As a result, some property owners that have already received notification about potential acquisition will receive requests for right of entry and others from whom property will not need to be acquired will also receive these requests for right of entry. Sound Transit staff have already begun receiving calls requesting clarification.

After the last discussion in October 2012, Council instructed staff to continue conversations with the City of Seattle regarding issues associated with annexation. Additionally, Council allocated \$250,000 in the City's 2014-2019

Capital Improvement Plan for creation of a Route Development Plan (RDP) for the corridor. However, Council directed staff to not actively pursue the annexation or begin the RDP until such time as Sound Transit identified the preferred alternative for Lynnwood Link light rail. On November 21, 2013, the Sound Transit Board identified the preferred alternative for Lynnwood Link and it includes a light rail station at Interstate 5 and NE 145th Street.
