## **Shoreline District Court Costs**

## **Summary**

The City of Shoreline and 12 others contract with King County for District Court services.

Revenue generated by infractions, and fines and fees associated with cases is used to offset total allocated costs for each city. For District Court services from 2008 to 2012, Shoreline paid an annual average of \$151,956 'out-of-pocket' (the portion of total allocated costs remaining after revenue is taken into account which must be covered by City-budgeted funds). The City's out-of-pocket costs increased by approximately \$40,000 in both 2013 and 2014. And, in 2014, Shoreline will pay slightly over \$240,000 for Court services.

Increases in out-of-pocket costs in 2013 and 2014 are notable since total allocated costs for all court services have decreased annually since their height in 2010. In 2010, Shoreline's allocated total cost was \$767,402, and in the years since, the City's allocated total cost has decreased to \$631,950 in 2014.

Traffic and non-traffic infractions are the main driver behind City revenue generation used to offset court costs. Total infractions (and thus revenues) decreased in 2013 and 2014. However, 2015 infraction rates are projected to increase by over 57% from 2014 totals, and thus, the City's out-of-pocket costs for 2015 Court services is expected to decrease, perhaps substantially.

Below is historical data on the City's case filings (including infractions), revenue, total allocated costs, and out-of-pocket costs, as well as graphical depictions which may be helpful in portraying the interplay between each.
