Over the past year, the City has been working with the community on developing improvements to the 175th Street corridor (175th Street Corridor Improvements Project) from I-5 to Stone Avenue N. The purpose of the project is to make needed street and sidewalk improvements, so the corridor is safer and more accessible for all.
