The benefit to the City would be preservation of the natural open space. This property would not be useful for active recreation. Debbie:

Staff from the King County Wastewater Treatment Division approached me several weeks asking about the City's potential interest in property they own adjacent to Kayu Kayu Ac Park and behind their Richmond Beach Pump Station. The County staff have proposed that they amend the current use agreement we have in place for Kayu Kayu Ac Park to include this 1.0 acre piece of property. Kirk and I toured the site last week with County staff. Attached is a map along with some pictures.

The property runs north from the Park between the railroad tracks and private property. The County has determined they do not need to the property for operation of the pump station. They have recently started to address several private property encroachments and undertaken environmental restoration of wetlands and surrounding area. They are doing a nice job of restoring and maintaining the property.

I initially expressed potential interest in the property with the concern that they might sell it to private interests. That does not appear to be the case. The County has plans to remove the encroachments and

install fencing around the property essentially preserving it in a natural state – which is an appropriate use for the property. Given the wetlands present it does not lend itself to active park use.

I recommend we do not pursue adding this to the City's park land inventory. We would become responsible for ongoing maintenance which, while not being an exorbitant cost, would be a new expense nonetheless. The land will still be preserved in public ownership.

Please let me know if you have questions or would like me to take another direction. I told the County I would get back to them by May 20th.
