Dear Business Person of <BusinessName>,

We are acutely aware of the impacts to our local businesses from COVID-19. We have established an internal COVID-19 business response team, and, in collaboration with partners around the region and at the federal level we are exploring every avenue possible to bring support to our businesses.

This letter provides important information on the City's efforts to support our local businesses through the Small Business Support Grant, Interim Regulations to support outdoor dining, and Business & Occupation (B&O) Tax Filing Deadline Extension.

B&O Tax Filing Deadline Extension.

The City of Shoreline offered relief to small businesses, as defined below, by extending the filing and payment deadlines for 2020's first and second quarter B&O tax and Gambling Tax returns until October 31.

Who Qualifies?

- Any person, as that term is defined in SMC 3.22.030(P), that is required to pay B&O Tax pursuant to SMC Chapter 3.22 and reported less than \$5,000,000 in taxable income for 2019.
- Any person, as that term is defined in RCW 9.46.0289, that is required to pay gambling tax pursuant to SMC Chapter 3.30.

This extension does not apply to those persons assigned to a monthly, annual, or active non-reporter basis.

How do I File?

Deferred tax returns for 2020's first and second quarter B&O Tax and Gambling Tax returns must be submitted on a paper copy of the Multi-Purpose Tax Return for 2020 Tax Deferral for Eligible Small Businesses, which can be found online at: shorelinewa.gov/businessoccupationtax. Please note quarter one and quarter two deferred returns must be filed separately.

Interim Regulations to Encourage Outdoor Dining

In July, City Council adopted interim regulations to allow restaurants and bars to safely add seating in parking lots, sidewalks, on-street parking areas, and other outdoor areas.

- Parking lots on private property: After submitting an Outdoor Seating Area Registration Form, eating and drinking establishments with access to a private parking lot can now use this area for outdoor seating. There is no application fee for this registration.
- Public right-of-way (public sidewalks, on-street parking, or other public space): To use a
 public space for outdoor dining, businesses must apply for a right-of-way site permit. We estimate
 it will take 7 business days to process these permits once all necessary materials are provided.
 The interim regulations include the waiving of the right-of-way site permit fee and the periodic use
 fee

Small Business Support Program

In June, the Shoreline City Council approved establishing a Small Business Support Program (SBSP) to provide \$500,000 in grants to Shoreline small businesses impacted by COVID-19. Funding for the program came from Federal CARES Act relief funds (\$410,000) and money allocated by the King County Council for local business support (\$90,000).

The SBSP received applications from 68 businesses totaling \$1.2 million in grant requests. Applications were scored based on the criteria approved by City Council including financial loss, recovery plan, potential jobs lost, placemaking, and independent businesses. Grantees received awards up to \$20,000. A full list of grant recipients is available at shorelinewa.gov/c19bizresponse. Where you can also sign up for news and updates.
