RE: Small Business Support Program Grant Award Recommendations

On June 8, 2020, City Council approved the City establishing a Small Business Support Program in response to the COVID-19 pandemic, which shuttered many businesses for over three months in the first half of 2020. Council made \$500,000 in grant funding available, reimbursable from the CARES Act Funding (\$413,909 from the City's CARES Act and \$86,091 from King County CARES Act Business Program funds).

The "COVID-19 Business Support Team" established a set of eligibility and scoring criteria for the grant program, which opened on June 12 and closed on June 22. The City received 70 applications for a total request of \$1,201,518 in grant awards. Of those, two were duplicate entries.

The Business Support Team recommended 32 businesses for a total award of \$500,000 to the City Manager for approval on June 30, 2020. Since that time, the City has been allocated additional CARES Act Funding. City Council intends to approve the City's spending plan at its October 12, 2020, meeting. The Small Business Support Program team would now like to recommend that additional funding up to \$262,297 (for a program total of \$762,297) is allocated for the Grant Program. The table below outlines the business name, initial grant awarded, second round grant award recommendation, and total grant award recommendation.

Awarded businesses will be required to sign a contract with the City and provide a W-9 before funds are distributed to approved businesses.
