








KING COUNTY HEALTH AND WELL-BEING MEASURES




To identify geographic areas of need, King County census tracts were rank-ordered from highest to lowest percent of adults by the areas noted above. The tracts were then divided into 10 groups. Dark reds show tracts with the highest rates; dark blues show tracts with lowest rates (note: the Life Expectancy map ranks shortest in dark red to longest in dark blue).




GREEN SPACE

 South King County, SeaTac & Kent have less open green space (red areas) than areas of North & East County



Transportation & Air Quality (from Metro Zero Emission Bus Equity Analysis)

- Combined air quality, health, and other demographic risk factors to determine communities most vulnerable to air pollution
- Darkest gray areas have highest risk factor scores

There are 2.5x more fast food restaurants and convenience stores compared to grocery stores in most areas


South King County has 5 to 7 times more fast food restaurants and convenience stores




POLICIES, PRACTICES & SYSTEMS – Policies, structures and systems – including those in government – have sustained and even contributed to inequities



Restrictive covenant modification

In 2018, Washington State amended its law against discrimination to provide property owners a way to strike racially restrictive covenants from documents affecting the title of their properties. If your property had a racially restrictive covenant recorded in the past, you can now record a molfication document with the county where your property is located.



Youth Detention Dashboard

Analysis: Though still overrepresented in detention, there were eighteen fewer black youth in detention in 2018 compared to 2015. This is the lowest number of black youth in detention in King County since 1998. After a five year increase in the number of Hispanic/Latinx and Asian/PI youth in secure detention, both groups experienced fewer youth in detention in 2018 compared with 2017.



In 1843, the Provisional Government of Oregon established a set of organic laws, including a ban on slavery: "There shall be neither slavery nor involuntary servitude in the said territory otherwise than in the punishment of crimes whereof the party shall have been duly convicted.

After a vote on June 26, 1844, the first Black Exclusion law reiterated a ban on all slavery in Oregon territory, while also forcing blacks and mulatto settlers to leave Oregon territory within three years (two years for men), or else to be whipped "no more than 39 times." As Oregon gains statehood in 1859, it is the only free state with a Black exclusion provision in its original constitution ever admitted by Congress.

Washington gains statehood in 1889.
