Shoreline Park serves the public in both a regional and neighborhood capacity. There is regional draw for park patrons who use the lighted all-weather turf fields and tennis and pickleball courts for tournaments and sporting events. The park also serves the location neighborhood with play equipment, wooded trails and for passive use activities such as picnics. The proposed pavilion would provide beneficial recreational activities to a variety of park patrons on a local and regional basis. As the park serves to draw a diverse community of recreational users there is an economic benefit to local businesses. A new pavilion would allow year-round outdoor recreation, increase park usage and add to the local economy as Park Patrons spend time in the City of Shoreline and frequently make expenditures.

Demolition and site prep: \$40,000 Fabrication of pavilion: 130,000 Design, permitting and construction: \$180,000

Construction of a pavilion at Shoreline Park would allow year-round outdoor recreation and extend park usage to the entire year. Shoreline Park serves the public in both a regional and neighborhood capacity. There is regional draw for park patrons who use the lighted all-weather turf fields and tennis and pickleball courts for tournaments and sporting events. The park also serves the location neighborhood with play equipment, wooded trails and for passive use activities such as picnics. The proposed pavilion would provide beneficial recreational activities to a variety of park patrons on a local and regional basis. As the park serves to draw a diverse community of recreational users there is an economic benefit to local businesses, as Park Patrons

spend time in the City of Shoreline and frequently make expenditures.

regional draw to all 12 months of the year. Park patrons frequently make expenditures a local stores and restaurants.
