NATURE OF APPEAL HEARING: Snohomish County Code Section 30.72.110 provides that the appeal will be heard at a closed record appeal hearing. **Appeal issues shall be limited to those expressly raised in the written appeal.** The appeal will be on the record with no new evidence allowed unless specifically requested by the County Council. No new appeal issues may be raised by a party of record after the close of time allowed by law for filing an appeal. Because this is not an open record hearing, members of the public who are not parties of record will not be allowed to present argument.

PRESENTATION OF ARGUMENT: Parties of record may file written arguments prior to the hearing and may present oral arguments at the hearing. Arguments are limited to the issues expressed in the written appeal; no new appeal issues may be raised. In order to be considered, written arguments must be filed with the Council Clerk, no later than 5:00 p.m. on Friday, March 5, 2021. The appellant may file written rebuttal arguments with the Council Clerk, no later than 5:00 p.m. on Friday, March 12, 2021. Arguments are encouraged to be submitted to the County Council through e-mail to <u>contact.council@snoco.org</u>. They may also be submitted at 3000 Rockefeller Ave., M/S 609, Everett, WA, 98201.

AVAILABILITY OF RECORD: The record, including the written appeal statement and written arguments presented by parties of record, is available upon request at the County Council Office, at the above address. The Council may affirm the Hearing Examiner's decision, may reverse the Hearing Examiner's decision, wholly or in part, or may remand the matter to the Hearing Examiner for further proceedings in accordance with the Council's findings and conclusions.
