Name of Project: Densmore Pathway Watershed Art Trail Phase 2

### Describe the project and intended impact.

Densmore Pathway is located just north of N.185th St Corridor within a neighborhood experiencing a continued increase in population growth, traffic and diminishing green space due to rezoning from single family to MUR 35, 45 and 70 for nearby Light Rail Station that is close to completion. Local residents as well as the Shoreline community are looking for walkability and greenway spaces to move from west to east while commuting, catching school buses, socializing, exercise and dog walking. Many choose to avoid N 185th due to noise and safety because of high traffic, aging sidewalks and MUR construction projects.

Phase 1 of this Watershed Art Trail metal salmon in "steam" brought many positive comments for users of the Pathway and a strong desire for more art and connection to the community and nature. Additional art for 2021 will include metal watershed wildlife using a nesting heron, fishing heron, school of salmon fry/young, and pollinator species such as dragonfly and butterfly. The salmon stream created with the 2019 Mini Grant will continue into Phase 2 by lengthening the stream eastward through the pathway with this new metal art to be discovered by users. Additional plantings of native plants such as snowberry and tall Oregon grape will enhance this experience. Additional signage will announce the pathway as a pesticide free green space and encourage others to do the same at their own homes.

What is the neighborhood opportunity or need identified and how does the project address

it? Who will be served? How this project build neighborhood connections? Increased density of population, car traffic and MUR construction has impacted the safe use of N 185th as a pedestrian and bicycle friendly thoroughfare due to old sidewalks and heavy townhome and lightrail construction. There is a need for walkable, safe and inspiring outdoor spaces. Much of this has been made more aware of during COVID such as working from home and the ability to travel. Some residents have switched to more economic and environmentally sustainable modes of travel necessitating safe pathways and trails for connecting with other neighbors or for commuting to jobs or errands.

Who was involved in the idea development and subsequent decision to pursue this project? Please attach Neighborhood Association meeting minutes at which this project was identified and approved by the Association for a Mini-Grant request.

Marla Tullio proposed Watershed Art Trail in 2019 and received full support from Echo Lake Neighborhood Association thereby receiving 2019 Mini-Grant for Phase 1. Marla is currently a Native Plant Steward with Green Shoreline Partnership and retired Marine Biologist with public education experience having worked at Seattle Aquarium for 38 years. Was also inspired by frequents visits to parks across the Western US including the Willapa Art Trail in SW Washington within the Willapa National Wildlife Refuge which uses "art to tell a story and to teach visitors about the wildlife and habitat found along the path". City of Shoreline Staff, David Francis and Constance Perenyi, also gave us input and much appreciated support.
