Good afternoon John,

This year I have the privilege of coordinating 2 awesome events that seek to raise environmental awareness, Green Shoreline Day and Arbor Day, and I'm reaching out today to invite representation from City Council.

The celebrations for both events will be held congruently across 4 separate City parks on Saturday November 13th, and will be attended by members of the public who sign up for the day through our volunteer coordinator, Forterra. City staff will be on site to setup and break down the 4 hour event, and to support our dedicated forest stewards, who will perform demonstrations of the day's activities; native plant installation and non-endemic species removal.

My predecessor, Tony Hamilton, informs me that both these events, Green Shoreline (first celebrated in 2019) and Arbor Day (first celebrated in 2012), have a good history of attendance from City Council.
