Great news this week for progress with documentation of Eluding No Pursuits... New policy changing the reporting process from Blue Team to Mark43 is in concurrence with Command. We expect the change to take affect shortly should no issues in concurrence arise, and we will brief the sergeants when it is "Go Time!"

I had the absolute pleasure on Tuesday of meeting with two classes from SWHS Independent Living. Students

expressed support and love for us in their police department, and we discussed personal safety, calling 911 and how they can also help keep our city safe. One student even expressed the importance of wearing your seatbelt, and they shared that the Para Educator seated next to them had received an infraction earlier that morning from Dep. Lipke for failing to do so. Their Para Educator did not seem as enthusiastic about the situation, however...

Tuesday evening, Sgt. Salter, Cpt. Meyer and I met with four of our additional public schools for more safety and emergency planning walk-thrus. The Superintendent, Fire DC Foster, and Ryan, our city Emergency Management Coordinator were all present for this partnership. We have eight more schools to schedule soon.

Wednesday morning, I was honored by a visit from our Consul General of the Republic of Korea, Eunji Seo, and her staff to discuss our Korean population in Shoreline, crime trends, and how we can partner to make our city safer. This was another extremely encouraging and productive conversation with one of our community leaders and the start of better teamwork.

Rabbi Davidoff of our Shoreline Jewish Center Chabad reached out to me this week asking for our support. As many of you know, the Shoreline Chabad does outstanding community outreach and charity work in and beyond our community. He and his wonderful family reach out often in support of all of us. Recently, a global threat was brought to their attention regarding direct threats to synagogues and centers affiliated with Chabad. We are working directly with Rabbi Davidoff on vigilance, safety and security. Please make time to increase our presence at and around the center.

I have been asked to join our interview panels for the eight finalists for our RCR (formally RADAR) Executive Director position over the course of two days this

week. With this request, I ask for any feedback you have about the program changes since implementation of the new ILA.

I would like to congratulate Deputies Stultz, Hurst and Oliver for their completion of probation this week! Thank you all for being a valued part of our Team!
