## Well Done-Deputies Dallon, Wunderlich

We want to recognize K9 Deputy Dallon and Deputy Wunderlich for their March 5th efforts deescalating a woman crisis. The commendation below, as written by Sgt. Fitchett, captures their exceptional work well.

*I would like to share with you the outstanding work of Deputies Dallon and Wunderlich for their response to a person in crisis on March 5<sup>th</sup>, 2024. The staff at an adult family home called 911 to report a patient destroying the house. As deputies arrived on scene they reported hearing glass breaking and a female yelling.*

*Inside they found a combative and suicidal woman who armed herself with a piece of broken glass. At first glance she appeared to be holding a baby, which was later determined to be a doll. Using de-escalation, time, distance and shielding, deputies Dallon and Wunderlich were able to calm and distract the woman to a point they could establish a rapport. At one point, the woman held the glass to her wrist threatening to cut herself, but Deputy Dallon was able to talk her into handing over the glass shard and walking outside to an ambulance. Then when safely out of the house, she was transferred to an Aid Crew and transported to the hospital for treatment. I especially appreciated that Dallon and Wunderlich took the time and consideration to educate the responding Aid Crew on the woman's triggers to prevent them from further agitating her.*

*The efforts displayed here in this incident set the standard of dealing with people in crisis and closely follow the department's expectation of de-escalation. Please add this commendation to their files as a record of their good work.*
