Strong Teamwork Leads to Arrests

It does not happen often, but Kenmore had two major incidents in less than two weeks. The responding officers did a phenomenal job securing the highly chaotic scenes.

The first of these was a homicide that occurred on August 20th, when a male intentionally ran over his stepfather with his vehicle, killing him.

Deputies Helmer, Ezell, Wren, and Shealey, along with Sgt. Snow, did a great job of locking down the scene, detaining the suspect, and having everything buttoned down for MCU.

The second incident was a shooting that occurred September 2nd, when a male entered his neighbor's house with a baseball bat and was subsequently shot. The shooting victim remains in critical condition and not doing well.

Deputies Hernandez, Gundogdu and Wren, along with Sgt. Campbell all responded first to the scene and were assisted by Shoreline Deputies Planalp, Starn, Jackson, Dromgool, Goundar, Coblantz, Trop, and Sammamish Deputy Zamora.

These are incidents where the partnership within our precinct is so critical and appreciated. Thank you to all of the responding and assisting officers at both incidents.

Thompson Compound Eviction



If you have ever been assigned to Kenmore, or worked OT in Kenmore, you have likely found yourself at the Thompson Compound. This is a multi-million-dollar waterfront property on Arrowhead Point. After well over a decade of issues, KCSO and Kenmore PD served a court ordered physical eviction at the residence last month. It was sold at a foreclosure auction earlier this year, but Thompson was still squatting on the property.



The new owner has now changed the locks and will begin the process of cleaning the property (which will take a long time). This is excellent news to the neighbors who have been the victims of the shenanigans that originated from this property over the years.

On a side note- Officers were dispatched to this now secured property on Labor Day weekend when unknown suspects arrived at the front gate in a stolen Tahoe and pulling a stolen trailer, with the apparent intention of collecting some of David's property. They managed to evade capture, despite the fleet footed efforts of Deputies Gundogdu and Carlin, K9s, and drones. Sadly, until all of the items are removed by the new owner, we are likely to be called back there.
