As some of you know, our own Facebook page also received both positive and negative comments regarding this event. In general, I do not pay attention to comments on social media. Over the years I

However, I was requested by the City to change the venue of the event because of the concerns of protest during our meeting. Deputy Schettler and MPO Ater responded to a welfare check at an apartment complex in Shoreline on March 8, 2025, at approximately 6:40 AM. Upon arrival, they found a 3-year-old boy, nearly naked, alone in the downstairs lobby. None of the apartment residents recognized him, but he appeared happy and intelligent. Without hesitation, Deputy Schettler offered his jacket and engaged him in conversation, while Sgt. Mandella brought clothes and games for him.



The officers soon located the child's home and learned that his mother was facing very difficult circumstances compounded by the recent loss of the father figure. MPO Ater actively listened and went out of his way to introduce the mother to our regional crisis responders (RCR) and to connect her with other independent resources, assisting not only her but her entire family. Deputy Schettler and Deputy Lipke helped her unpack and pick up around the house. While this may seem like a small gesture, it provided much needed support in a challenging time. Our officers are not only skilled investigators but also demonstrate empathy by putting themselves in others' shoes.
